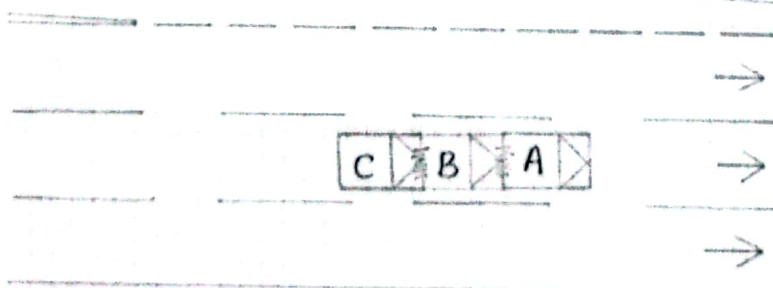

PIE TWRB KJE (RIGHT AFTER KPE EXIT).



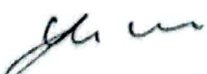
A - SLT 8309K
