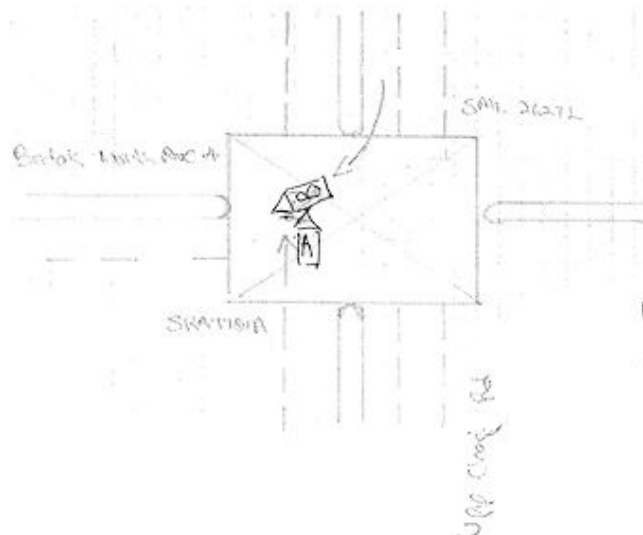
Sketch Plan

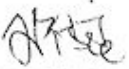

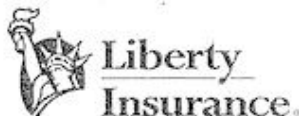
