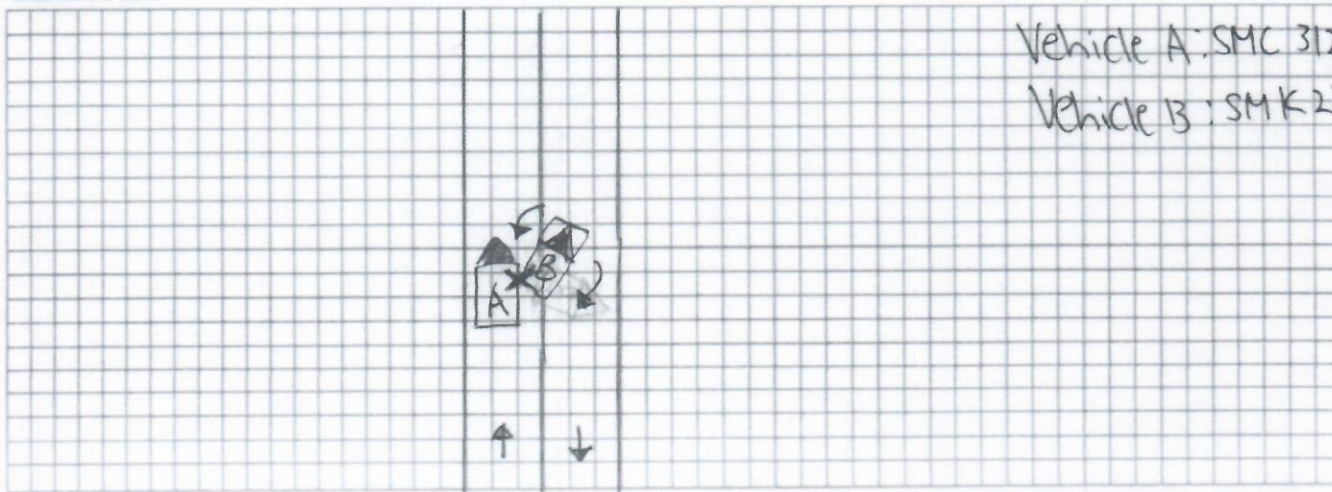

Sketch Plan




