

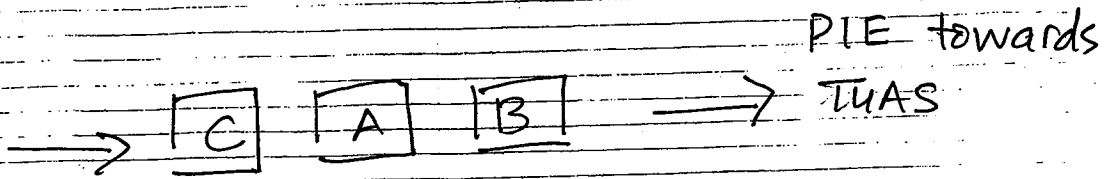

Vehicle C : SKR5356R


