I, Dawn Eayrs, (G3972757P) was en route to collect my daughter (Olivia Eayrs) from a playdate with her friend at Block 170, #02-25 (Lobby 8) @ The Sixth Avenue Residences. I left from my residential property at 3 Ming Teck Park in my Black Tesla Model 3 Performance car license plate SND1222H at about 18:54. I exited 3 Ming Teck Park turning right towards Sixth Avenue, I entered Sixth Avenue safely turning left and continued straight down towards The Sixth Avenue Residences. On approaching The Sixth Avenue Residences I indicated early that I would be turning left into the entrance where the security gatehouse and entrance barriers are located. On turning left into the entrance I noticed that a female pedestrian was looking to cross from my left-hand side to the right-hand side of the entrance and the barrier was still down so I stopped the car to allow the female pedestrian to cross. Very shortly thereafter a Black Mercedes Benz 450L car license plate SJM801T which was being driven at high-speed by a Mr Quek Jin Oon (0158119H) smashed into the rear right-hand side of my car and launched me forwards, last thing I can recall is trying desperately to avoid hitting the female pedestrian and The Sixth Avenue Residences security guard who has sat outside. When I came to, I noticed my car was smoking and exited the vehicle as quickly as I could. The security guards and a passerby helped me to sit down as I was in a state of shock. A passerby retrieved my phone from the car to allow me to phone my husband Nicholas Eayrs (G4031613U) and I told him what had happened. 




When I came to, I noticed my car was smoking and exited the vehicle as quickly as I could. The security guards and a passerby helped me to sit down as I was in a state of shock. A passerby retrieved my phone from the car to allow me to phone my husband Nicholas Eayrs (G4031613U) and I told him what had happened. The security guards and passerby moved me to the lobby area where I could be safely sat and called an ambulance. The ambulance arrived within 5-10 minutes and my husband shortly thereafter. My husband took down the details of Mr Quek, the main security guard witness Raman who can be contacted on 98975005 and witnessed the entire accident. In addition, the gatehouse has full video footage from their security cameras which I would ask the Investigating Officer(s) to retrieve. My husband also handed over our Tesla's usb thumb drive to the police for video retrieval as well. The Singapore Police Force acknowledgement slip is D/20220205/0108 and the Investigating Officer is Zickie 65476904. We have tried contacting Zickie, no answer as yet. We have also notified our Insurance company = Liberty Insurance and they arranged for towing of the vehicle from the accident scene. I do not believe I was at fault and based upon the stopping point of Mr Quek's vehicle at the accident scene he was clearly driving way too fast as his vehicle ended up stopping many metres past The Sixth Avenue entrance. In addition, the force created from the impact totally destroyed
