We refer to the above subject matter. We write to inform you that we are the loss adjuster appointed by your motor insurer, AIG Asia Pacific Insurance Pte. Ltd. to deal with the third-party claim against your policy.

We have received a claim from GBF187P against your insurance policy.

Based on the accident report and accident scenario, we are of the view that liability is not in your favour. Under Motor Accident Guide, driver should not overtake from the right at a road junction by traveling against the flow of traffic. Therefore, we shall proceed to negotiate for an amicable settlement of the third-party claim at best to avoid further litigation, which would escalate to even more cost.
