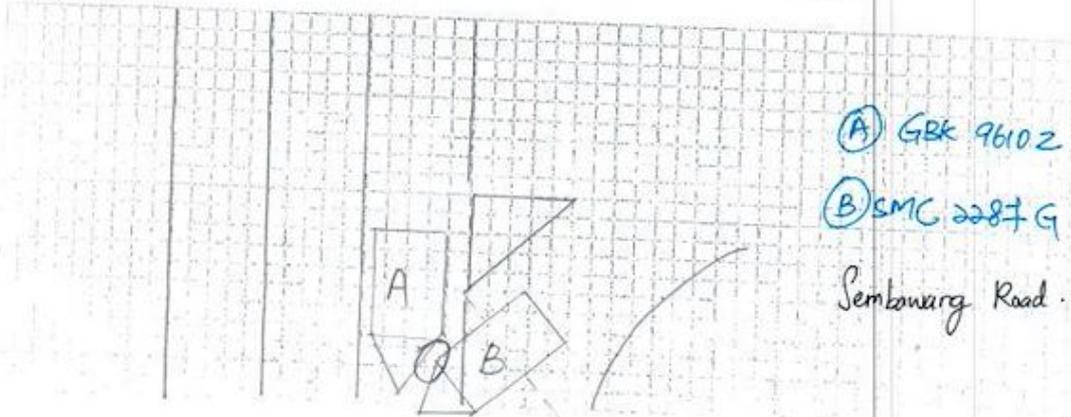

Describe Characteristics of the Accident
