## Brief Details.

As I was injured, the driver called for ambulance and I was conveyed to Khoo Teck Puat hospital and was given 05 days medical certificate from 10/02/2022 - 14/02/2022. I suffered from injuries such as having a cut on left ankle that later requires stitches, abrasion of left leg and aching on the back.
