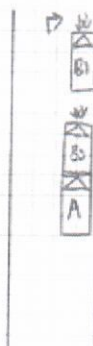

Vehicle B: YP5316U





Describe Circumstances of the Accident
