

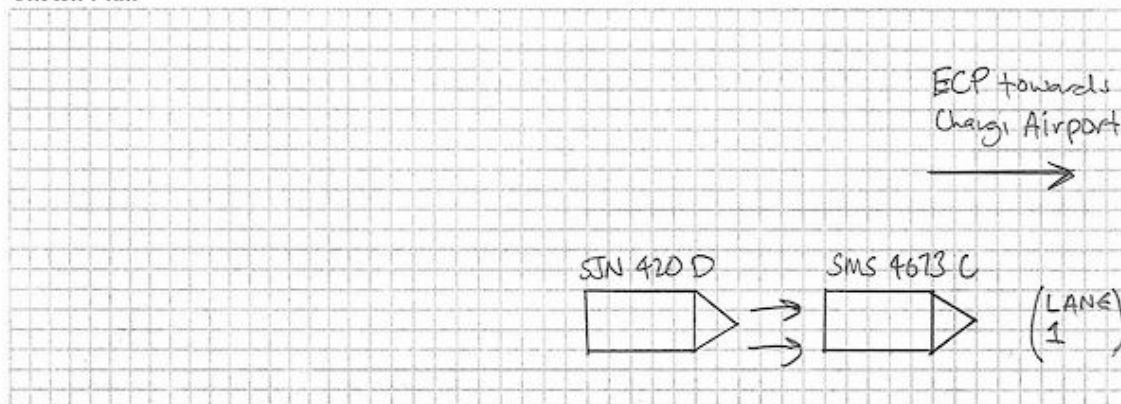

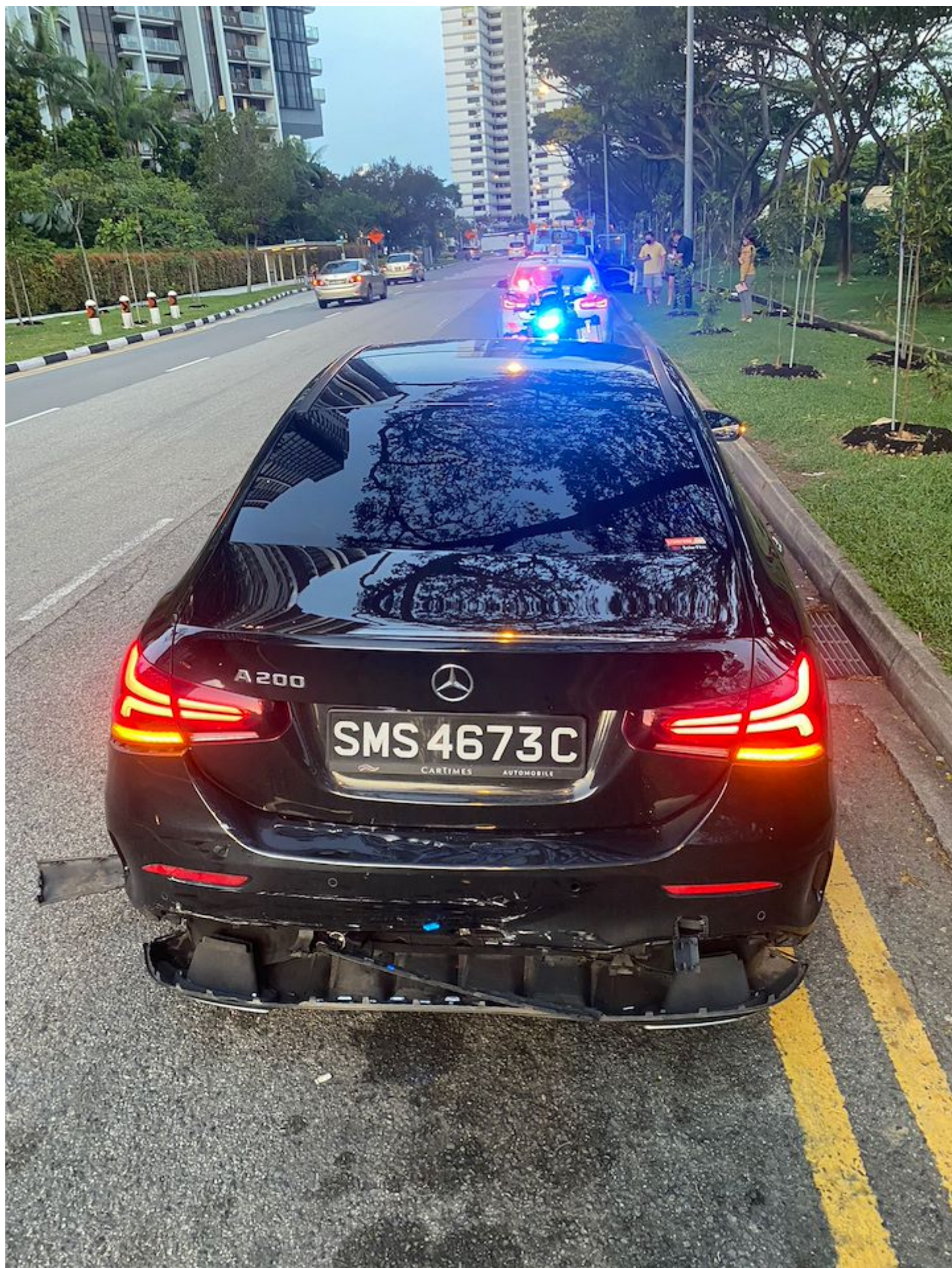
Sketch Plan

Brief details.

On 14/02/22 at about 6:10 pm, I was driving my car SJN420D on lane 1 of the ECP in the direction of Changi Airport. Traffic was smooth and not too heavy at that time, and the weather was bright and clear. In my car was myself and my wife seated in the front passenger seat. Suddenly, the car in front of mine, a Mercedes-Benz A200, braked and I also braked. Then, the driver braked again, and this time braked hard, coming to an abrupt halt. I braked hard but I couldn't stop in time, and as a result, my car hit the rear of the Mercedes-Benz A200.

The impact was so hard that it immobilised my car, with some smoke coming out. As I was trying to process this, the Mercedes-Benz A200 accelerated and did not stop to check on both our vehicles or to render assistance. As I was in shock from the whole incident and my car was immobilised from the damage, I was unable to take action to move my car. The driver in the car directly behind me, Ruiyi (in a black Volkswagen Golf), stopped his vehicle to render assistance and called both the ambulance and police. Myself, my wife in the passenger seat and the kind driver who assisted were appalled that the other driver simply drove away from the accident scene without exchanging particulars or rendering assistance. Thankfully, the entire incident was captured on my car's dashcam.

An ambulance came and paramedics assessed me, but as I seemed uninjured, I decided not to follow the ambulance to the hospital. A Traffic Police officer then arrived to manage the accident. It was here that I related to the Traffic Police officer the entire sequence of event, and how the Mercedes-Benz A200 did not stop after. The said officer then requested to view my dashcam footage, and this is when we managed to capture the registration number of the Mercedes-Benz A200 in question: SMS4673C.

The officer then made a call to his IO to report on this incident and to assist in getting the details of SMS4673C. I was then told by the officer that his IO had gotten in touch with the owner of SMS4673C, and that the driver of SMS4673C will return to the scene of the accident. At this point, we - myself and my wife and car SJN420D, the Traffic Police officer and LTA Traffic Marshall - had already moved to a safer location, Siglap Link (in front of Seaside Residences).

At 7:20 pm, more than an hour after the accident, SMS4673C finally showed up. A woman who claimed to be the driver, and her husband, gave a short statement to the Traffic Police officer, and after that, both

parties were told by the said officer to exchange particulars and make an insurance report. After this, my car was towed away to my workshop.

I am lodging this formal Police report as I have reason to believe that there is some dishonesty on the part of SMS4673C.

1. Firstly, the driver did not stop immediately after the accident, as required. Instead the driver fled the scene.

2. Secondly, had it not been for my dashcam footage, from which the Traffic Police got hold of their licence plate, would they have returned to the accident scene?

Instead of stopping to assess and render assistance - in case any of us were injured as a result of having to brake hard after SMS4673C's e-brake - the driver immediately drove away from the scene. This is highly questionable. Even the driver of the car behind me had immediately stopped to render assistance as, from his perspective, it was a very bad accident.

3. Thirdly, how can I be sure that it is the same driver who was behind the wheel at the point of the accident? The driver - whoever it could be - could have driven somewhere else and changed drivers before being called by the Traffic Police to return to the accident scene.
