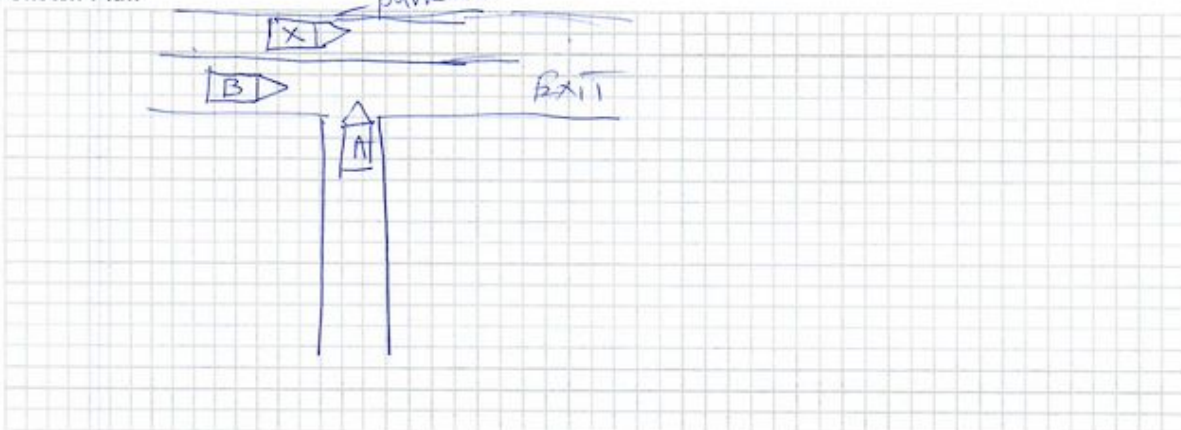


When this accident happen. at car park at
