### **Brief Details.**

On 19/02/2022 at 1030hrs, I was riding my motorcycle, JRC5013 along Jurong East Avenue 1 towards Jurong East Central. When I was approaching the junction of Jurong East Avenue 1 and Jurong East Street 21, the traffic light was in green and there were a few vehicles at lane 1 waiting to turn right into Jurong East Street 21. I was riding on lane 2. Then, a double cab lorry, YN6437P, which was at stationary on lane 1 changed lane suddenly turned into my lane. I was unable to stop and collided onto the left rear door of the double cab lorry. I was thrown off my motorcycle and landed on the grass patch. I dislocated my right elbow.

Traffic Police and ambulance came, and I was then conveyed to Ng Teng Fong General Hospital by ambulance. I discharged on the same day with 7 days MC. I have an MRI appointment at Ng Teng Fong General Hospital on 23/02/2022.
