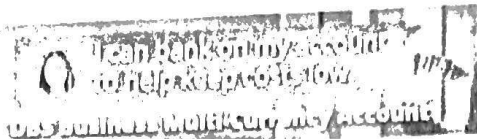

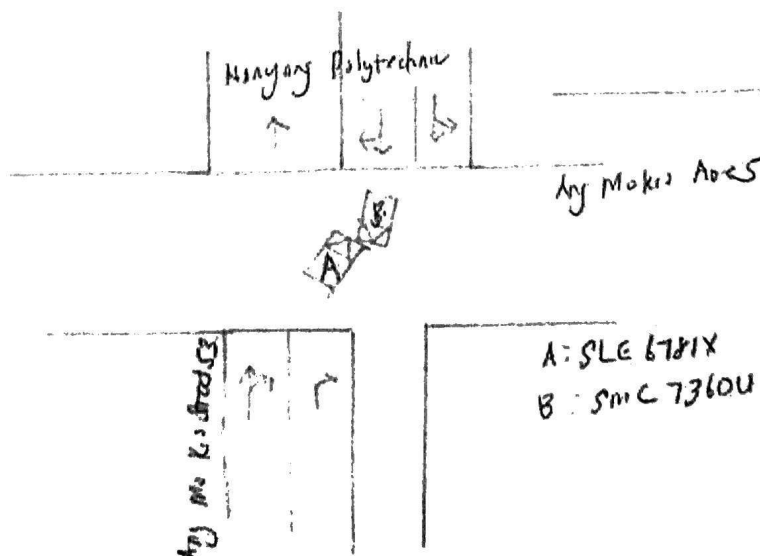

Sketch Plan




