**CONTINUATION OF REPORT**

**Brief Details.**

On 10 February 2022 at around 1800hrs, I was riding my motorbike with plate number RV9550 along Ayer Rajah expressway. It was drizzling and the ground was wet. My motorbike was behind a ComfortDelgro taxi with car plate number SH8872E and there was a car with car plate number SME782X on lane on my right.

There was a traffic accident in front of SME782X, hence the driver wanted to avoid the accident and turned into my lane without signalling. Hence SME782X collided into SH8872E and I was unable to brake in time and collided into the middle of the two vehicles. Both SME782X and SH8872E has slight damages on their car. My motorbike handle and front part are slanted.

The driver of SME782X is Koh Soon Hock and his IC number is S7442572J. The taxi driver is Tan Chun Kiat (Chen Chunjie) with IC number S8030345I.

The driver in the car behind my motorbike informed that his in-car camera has captured the whole accident. His name is Bernard Sim and his contact number is 98779199. I am not sure if the other two vehicles have in-car cameras.

My right leg is swollen and i feel pain in my right hand and it is slightly swollen but I did not see a doctor. CISCO officers were at scene.

I am making this Police report for insurance purposes.
