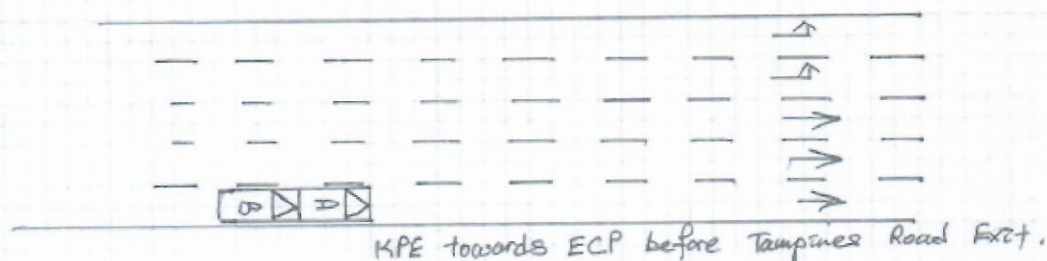

(B) SKU 3811R.





Describe Circumstances of the Accident
