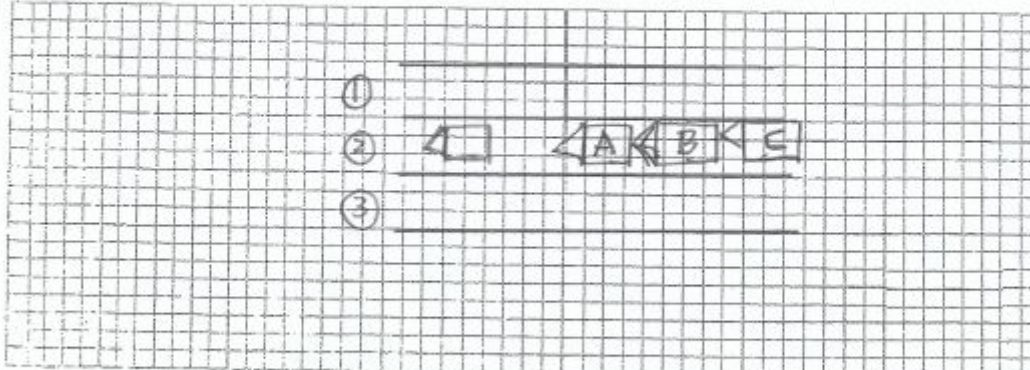

Describe Circumstances of the Accident

I WAS DRIVING ALONG CTE TOWARDS SLE/TPE ON LANE 2 BEFORE TIONG BAHEU EXIT 1B ON 01/03/2022 AROUND 17:51PM. IT WAS RAINING HEAVILY AND DUE TO TRAFFIC JAMMED IN FRONT, THE VEHICLE WAS SLOWING DOWN AND STOPPED. I ALSO BRAKE AND STOPPED WITH THE DISTANCE IN MY LANE. SUDDENLY I HEARD A LOUD 'BANG!' FROM MY VEHICLE BACK & I WAS VERY SHOCKED. AFTER A WHILE I DROPPED OUT TO CHECK MY VEHICLE, IT WAS A LORRY VEHICLE NUMBER. GZ 2054L COULDN'T BRAKE IN TIME AND IMPACT TO MY VEHICLE VERY SERIOUSLY & DAMAGED. I ALSO NOTICED THAT ANOTHER VEHICLE NUMBER GBB T296H ALSO HIT TO LORRY VEHICLE CAUSE THIS CHAIN COLLISION ACCIDENT.

WE EXCHANGED OUR PARTICULARS AND I DROVE MY CAR TO THE WORKSHOP TO MAKE REPORTING AND WENT TO SEE DOCTOR IN THE NIGHT BECAUSE I FEEL NOT COMFORTABLE AT MY BACK.

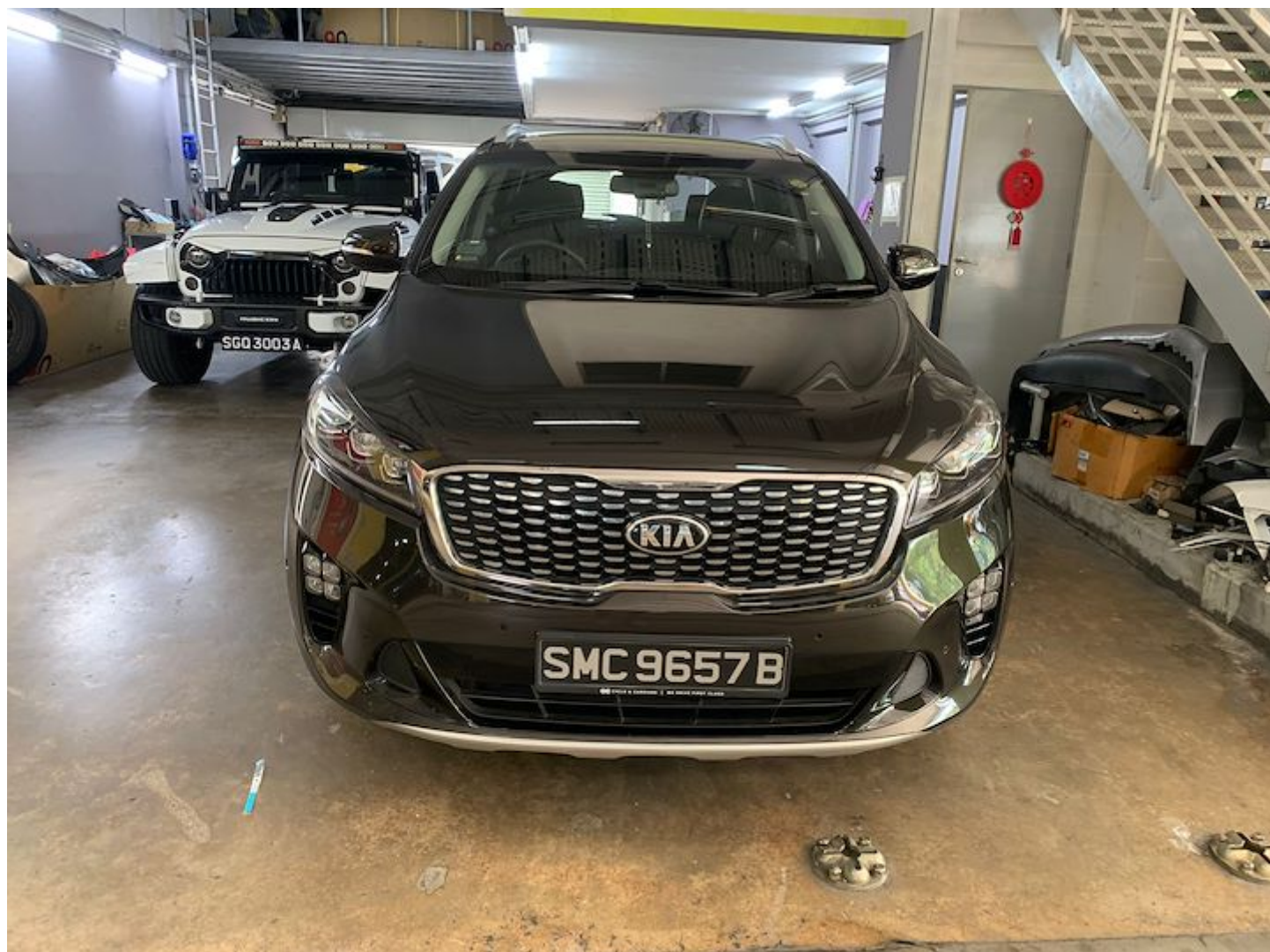

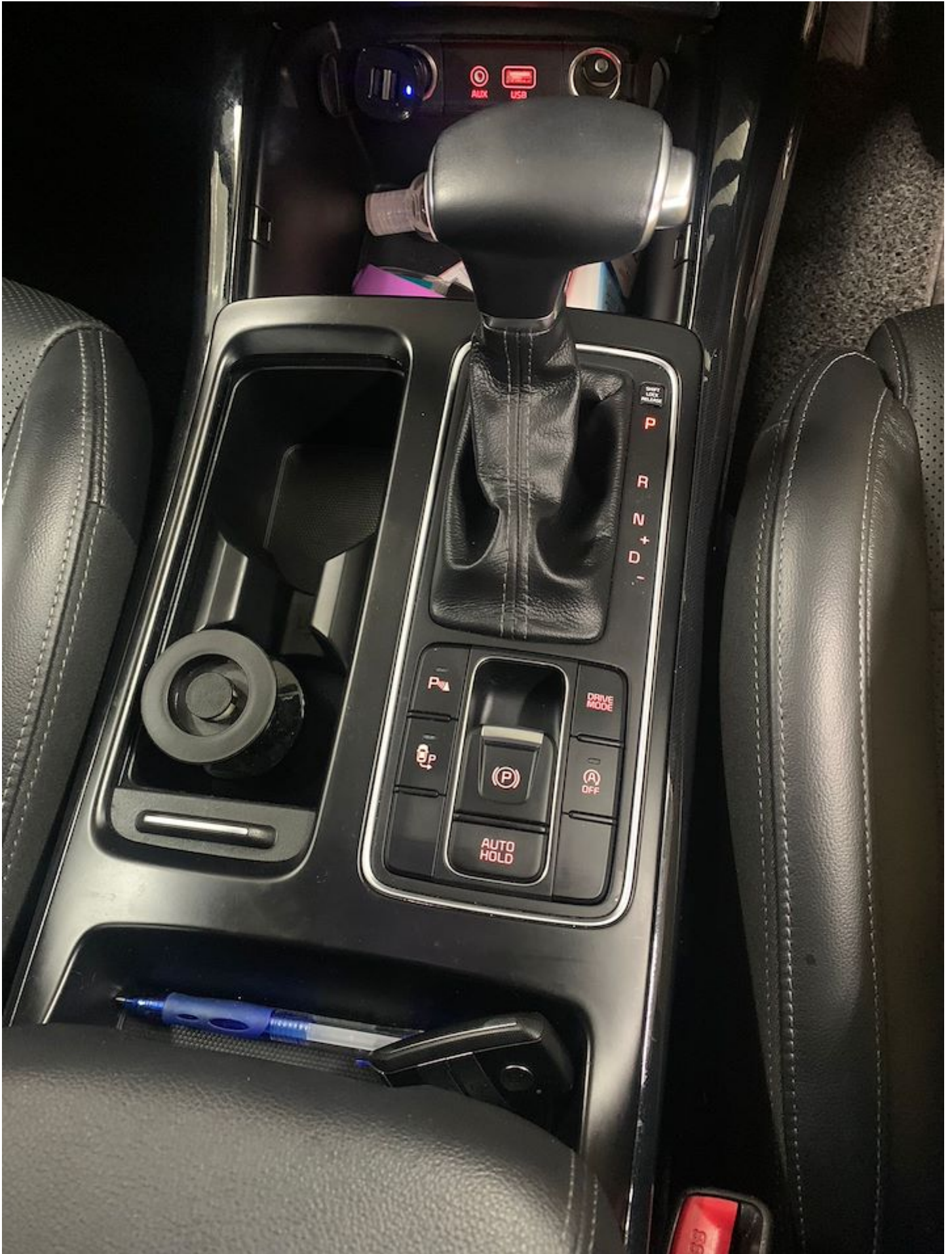








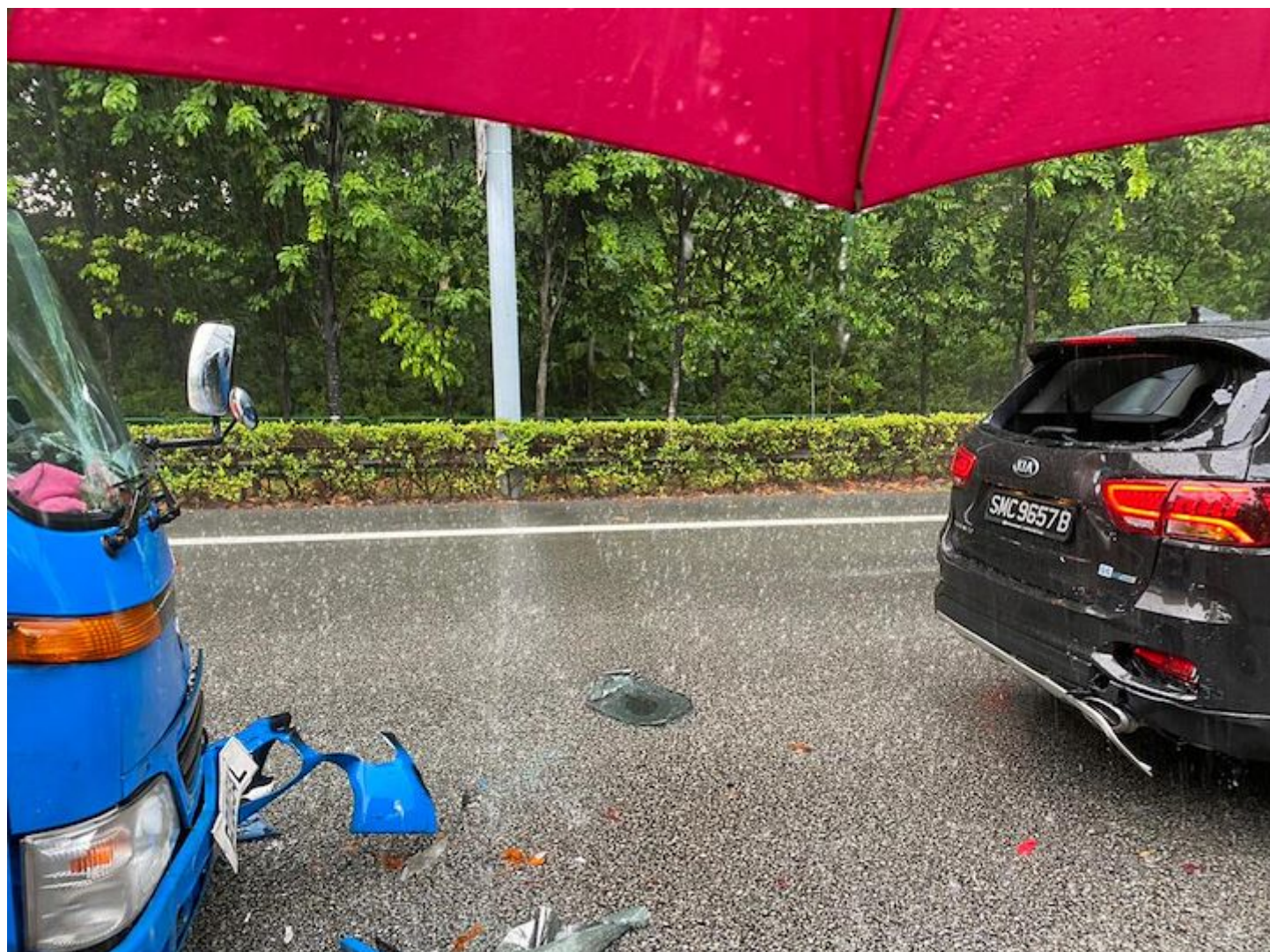

Brief Details.

I was driving along CTE towards SLE/TPE on lane 2 before Tiong Bahru Exit 1B on 01 Mar 2022 around 17:51pm. Suddenly, I heard a loud 'BANG' from the back of my vehicle. I was very shocked. After a while, I drop out of my vehicle to check and realised that it was a lorry vehicle number GZ 2054L which couldn't brake in time. The impact on my vehicle was huge and it was serious damage to my car. I also noticed that any vehicle number GBB 7296H also hit onto the lorry and thus caused this chain of collision accident.

We exchanged our particulars and I drove my car to the workshop to make a report and went to see a doctor at night because of the strain of my neck and lower backache.
