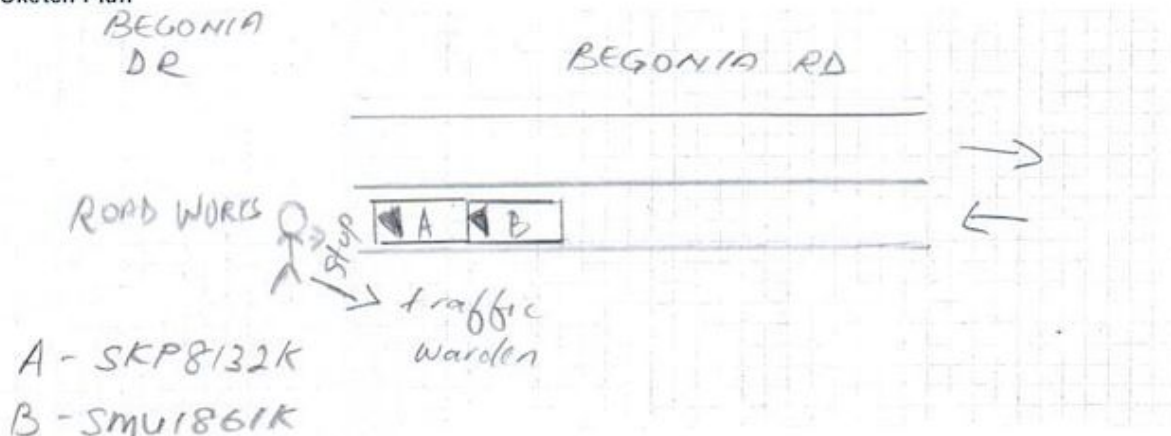

I was travelling along Begonia Road. Infront there was road works ahead. A traffic warden stop my veh coz to let the ^{veh from} other direction to move.

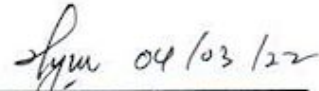
Suddenly veh B came from behind and hit onto my rear portion of my veh.

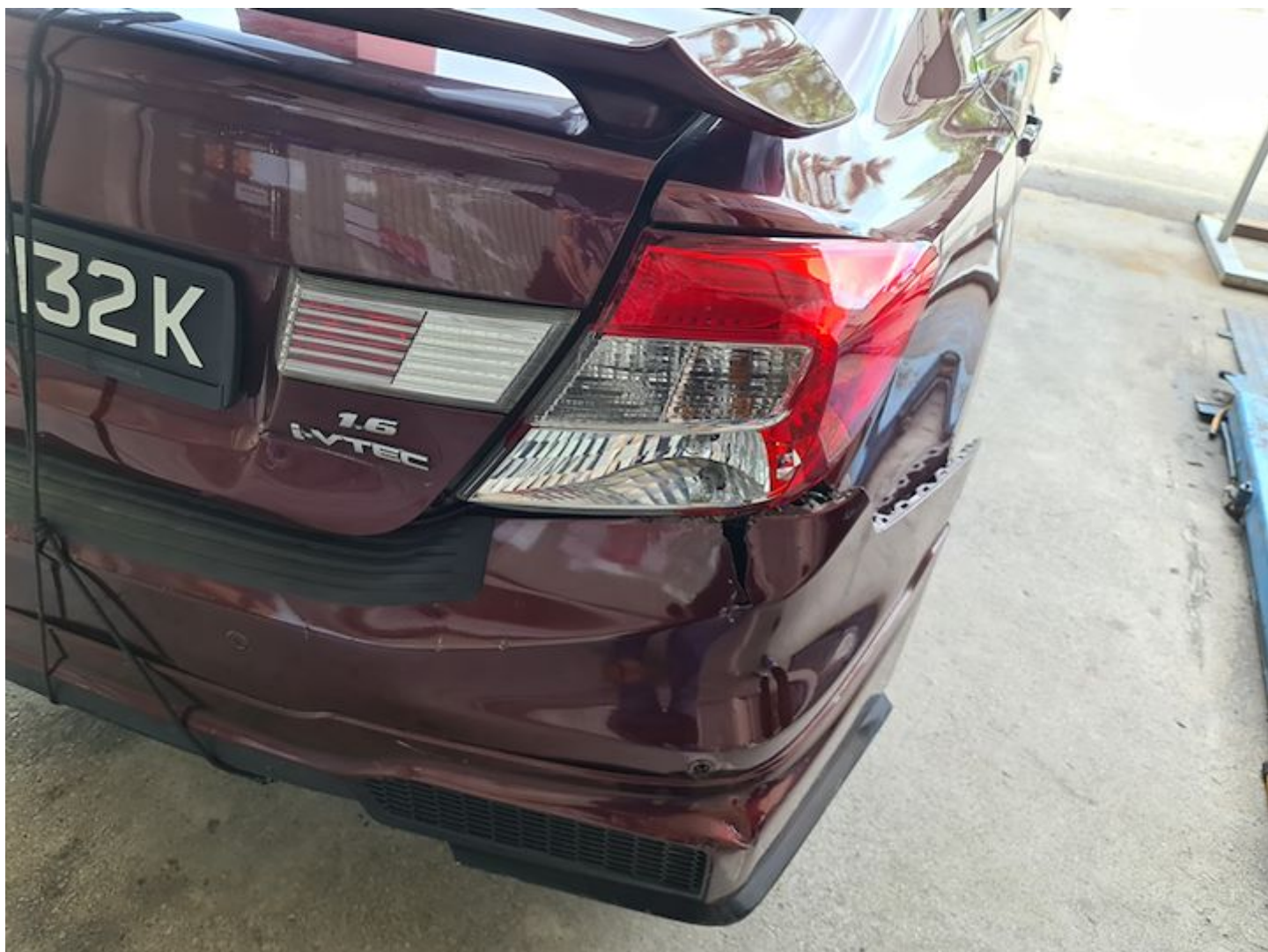






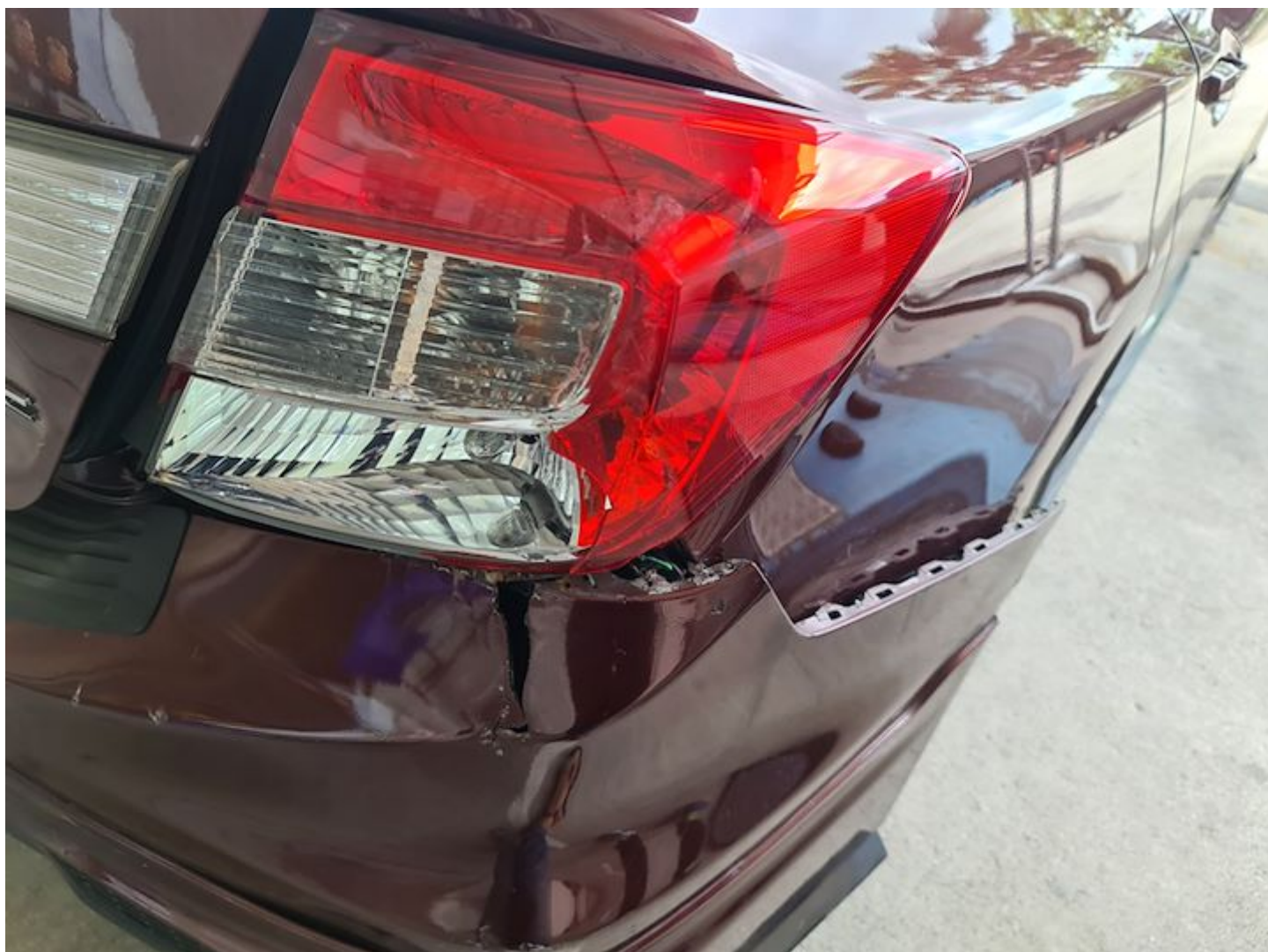
