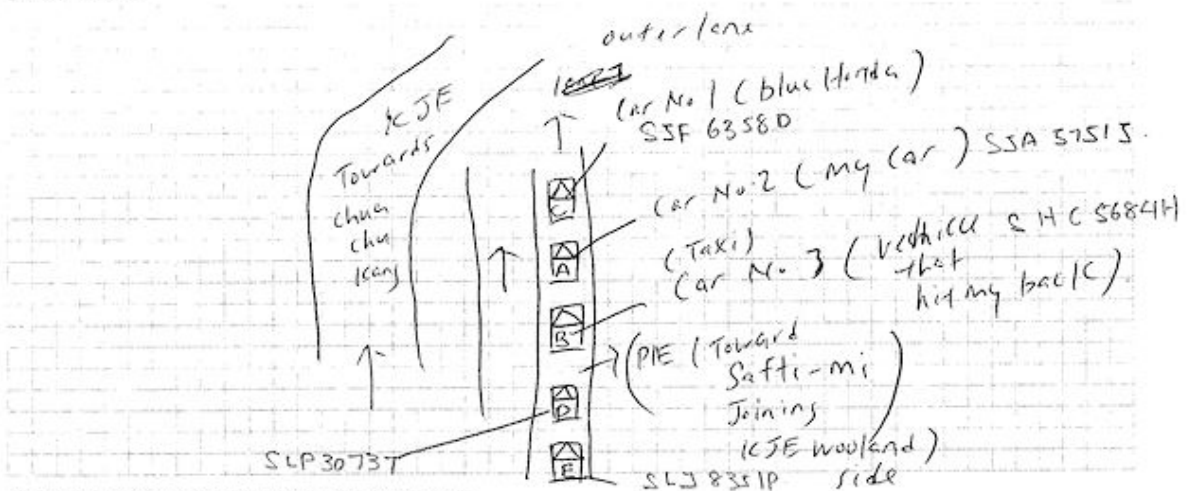

DESCRIBE CIRCUMSTANCES OF THE ACCIDENT

On 4 March, 2022, 0730 hrs, I was driving throughway Saffi-M, at lane 4 Outer lane. Car No. 1 stop due to slow traffic, I stop too and both mine car and Car No 1 (Honda) came to a completed stop. Suddenly I heard loud braking sound from my back. I immediately looked at my rear mirror, saw a red Taxi vehicle No SHC 5684H approaching fast and I was hit hard on my rear which the impact causing my car to move forward and collide with front vehicle (Blue Honda vehicle no SSF 6358D. Came down the car to take photo for evidences and exchange our particulars. Taxi driver had mentioned and admitted to hit my vehicles from the rear and causing damage to my car.
