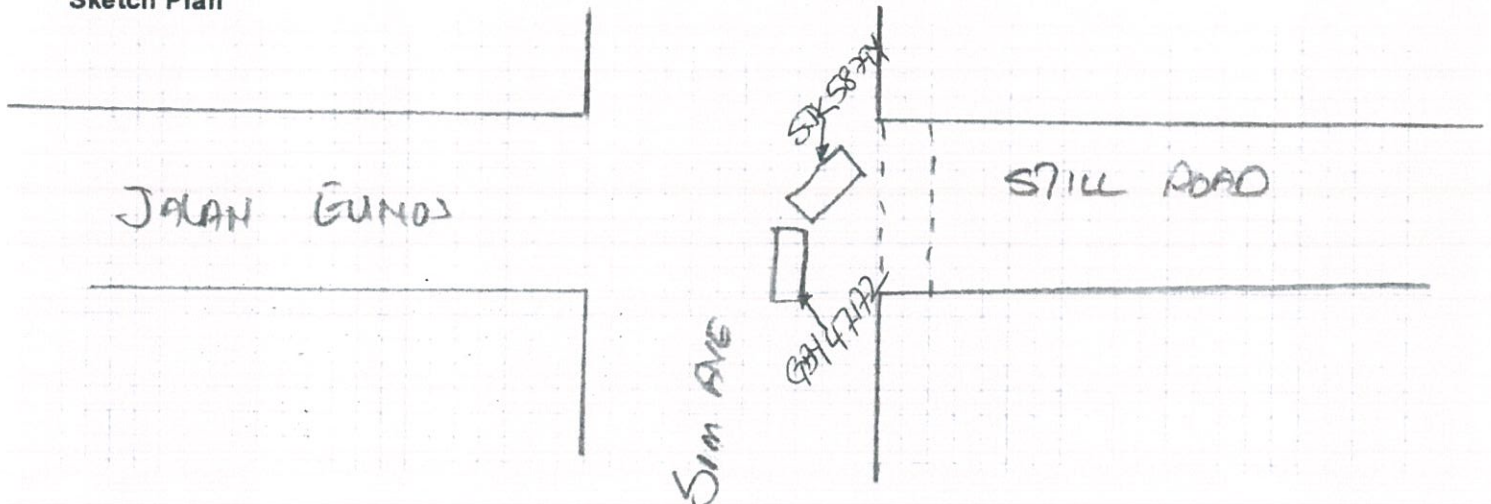

Sketch Plan




