1	TP/IP/51935/2021	On 2 November 2021 sometime before 2.56 p.m., the Deceased was driving his van at the said car park service road when he failed to keep a proper lookout ahead, collided onto the pedestrian, who was walking across the service road at the sheltered walkway from his left to right. Pedestrian succumbed to his injuries and passed away on the same day at 3.45pm. Driver of GBC9366X was conveyed to KTPH and pronounced dead on the same day at 10.06 am. PMA rider was conveyed to KTPH and pronounced dead on the same day at 1.48 pm. Deceased was conveyed to the hospital and pronounced dead at 1.25am by attending Doctor. The motor cycle, FBS1612D, was riding the said motorcycle on lane 1 of 2-lane road along Tampines Avenue 3 towards Tampines Avenue 4. A detailed mechanical inspection is required to eliminate any mechanical fault or any possible defence and to rule out foul play.		
9	TP/IP/20377/2021	On 23rd of April 2021 at about 2.48 a.m, Police incident was created regarding an accident along Woodlands Avenue 9 towards Woodlands Avenue 10, signalised cross-junction of Gambas Avenue. The motor cycle, FBC3804M, was riding the said motorcycle on lane 1 of 3-lane road along Woodlands Avenue 9 towards Woodlands Avenue 10. In the midst of making a right turn on green signal across the signalised cross-junction, the rider self-skidded and fell onto the ground. The rider was conveyed to Khoo Teck Puat Hospital ('KTPH') by ambulance. The rider is still currently in the hospital and unable to ascertain if there was any mechanical faults to the motorcycle. The driver was reported to be unconscious and sustained cardiac arrest, and succumbed to his injuries upon his arrival at National University Hospital. 	when he informed that the engine of the tipper truck had stalled while driving, resulting in the steering wheel locked and tipper veered to the left. The driver was unable to stop in time and collided onto the left guard railings. A detailed mechanical inspection is required to eliminate any mechanical fault or any possible defence and to rule out foul play.		
12 TP/IP/55223/2021	On 20 November 2021 sometime before 3.24 a.m., the motorcar was negotiating a U-turn when it lost control and mounted the left kerb and ended up on the footway. The driver claimed that the rear left tyre punctured while he was making the U-turn which caused him to lose control of the vehicle. The driver also claimed that the brakes were not effective when depressed. Initially, the driver did not raise any mechanical fault issues but later claimed so. Hence, the workshop had changed both of the left side tyres and rims. However, the puncture front left and front rear tyres and rims were placed in the boot of the car. The other aspects of the vehicle were not repaired. 13 TP/IP/45751/2021	On 9 Dec 2021 at about 8.35 am, motorcar SGY2140B was involved in a minor RTA with another car and government property. In gist, the driver of motorcar SGY2140B claimed that the collision by the other motorcar caused her brakes to fail. Hence, the car was unable to stop and continued towards the footway and collided onto a shelter. Driver claimed her brakes were working fine before the collision and the collision was likely to have caused her brake to fail afterwards. Nearing the nonsignalised T-junction of Jalan Taman, the Deceased was seen walking across the road while pushing a trolley with empty boxes, directly ahead of the Accused's motorcar from Accused's left side to right side. Moments later, the frontal portion of the Accused's motorcar collided onto the Deceased's right side, causing the Deceased to flung forward and landed ahead of the Accused's motorcar. The Deceased sustained multiple injuries and was conveyed to Tan Tock Seng Hospital by the ambulance. Upon his arrival in National University Hospital, the Deceased succumbed to his injuries and was pronounced dead at 5.45 a.m. by Dr Chin Hao Ren. 15	TP/IP/56095/2021	On 24 November 2021 sometime before 6.44 p.m., the Deceased was riding alone on his motor scooter and was travelling straight along Delta Road towards Lower Delta Road, after the nonsignalised T-junction of Delta Avenue on lane 2 of the 2-lane road. Out of a sudden, the Deceased's motor scooter and the Deceased self-skidded and the motor scooter landed on lane 2 while the Deceased landed on the grass verge near his motor scooter. The Deceased was reported to be unconscious and sustained cardiac arrest hence he was conveyed to Singapore General Hospital by the ambulance. The Deceased was pronounced dead at 8.43 p.m. by Dr Jason Tong Weng Yew in Singapore General Hospital. 16	TP/IP/57551/2021	On 4 December 2021 sometime before 2.21 p.m., based on the video footage retrieved from a WCEGA Plaza, it revealed that the Deceased was standing alone on the pavement, before the signalised pedestrian crossing along Bukit Batok East Avenue 3 towards Bukit Batok Central as it was red man. As the traffic light for the Deceased's direction changed from red man to green man, the Deceased walked along the signalised pedestrian crossing towards the direction of WCEGA Plaza. While she was doing so and was covering lane 1, the Accused's motorcycle was seen travelling towards the Deceased from the Deceased's left side to right side. The front portion of the Accused's motorcycle collided onto the left side of the Deceased, causing the Deceased to fall on the road. 19	TP/IP/57589/2021	On 4 December 2021 sometime before 10.56 p.m., based on the video footage retrieved from the Witness' motorcar, it revealed that the Deceased's van manouvering the right bend along CTE (SLE), slip road into Seletar West Link on lane 1 of the 2-lane road when it encroached into a travel path of a blue taxi travelling on its left side then travelled on lane 2. After which, the Deceased's van continued to veer to the right into lane 1 and moments later, the Deceased's van mounted the right kerb and hit onto a tree. Due to the impact, the van landed on lane 1. A detailed mechanical inspection is required to eliminate any mechanical fault or any possible defence and to rule out foul play.
