



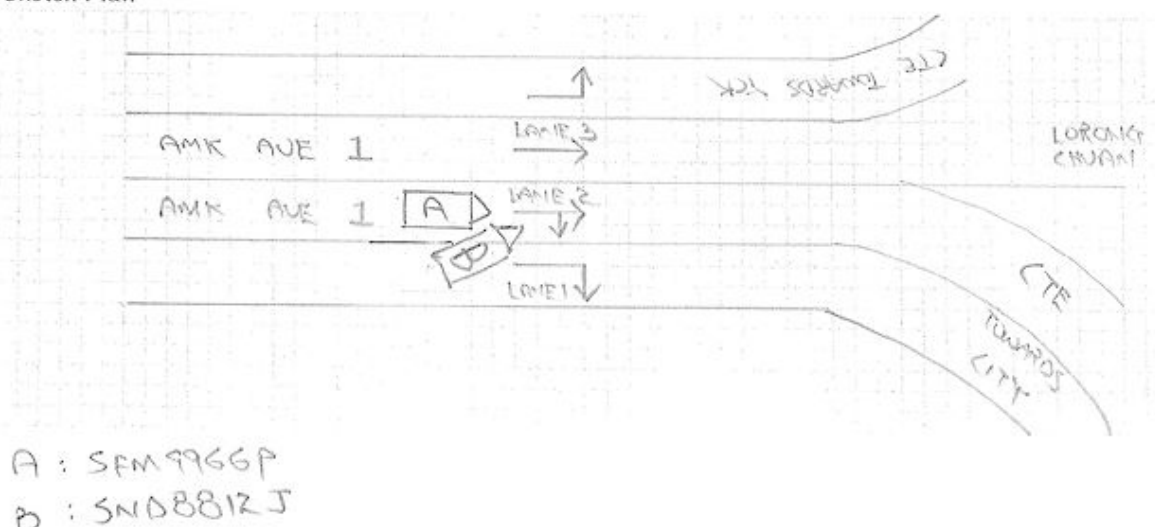

All of a sudden, vehicle SMO 8812 J cut into my lane. I applied E-Brakes but still cannot avoid a collision.


and swerve to my left bumper


My front extreme right corner hit into his back extreme left bumper
