

Describe Circumstances of the Accident

On 2/3/2022 at about 1310 hour, I was driving SM7971M along Farrer Road towards ~~to~~ ~~to~~ ~~to~~ Duncorn Road with 2 passengers onboard. I stopped at the junction of Farrer Road and Bukit Timah Road and was on the extreme right lane of 4 lane (only right turn) due to red light. When the lights turned green, I proceeded to move forward to go straight. Just as I passed the traffic light where I was, a taxi suddenly cut in front of my car, coming from my left. ~~I~~

I made an immediate brake in the middle of the cross junction of Farrer Road and Bukit Timah Road. The taxi continued to swerve into my lane and caused ~~an~~ an impact on the front left bumper and vent. My car was stopped in the middle of the cross junction of Farrer Road and Bukit Timah Road.




