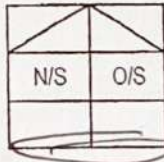

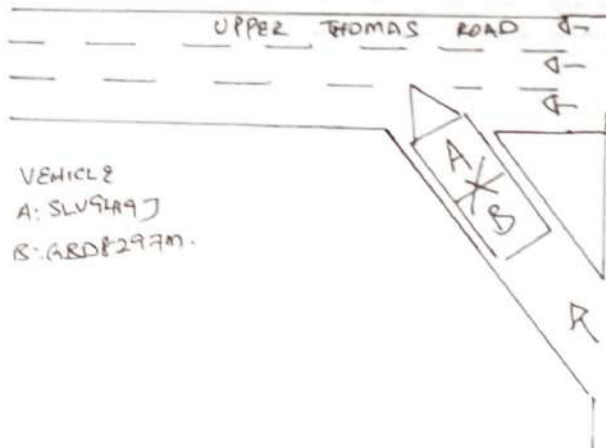

Describe Circumstances of the Accident

ON THE STATED DATE, TIME AND LOCATION. I WAS TRAVELING ON THE SUP ROAD FROM YIO CHU KANG TO THOMSON. UPPER THOMSON ROAD. I SLOW DOWN AT THE SLIP ROAD TO LOOK OUT FOR ON COMING VEHICLE. OUT OF A SUDDEN, THERE WAS A HUGE IMPACT CAME FROM MY REAR. I ALIGHT AND REALIZE VEHICLE "B" HAD COLLIDED ONTO MY VEHICLE "A".
