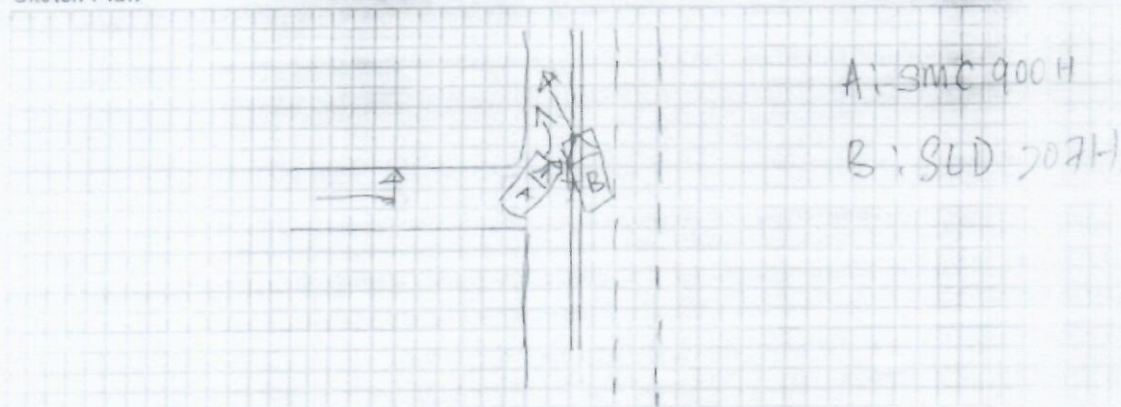

I was driving out onto Holland Road from Lorong Mambong. At the junction I stopped my vehicle to ascertain that it was safe for me to drive forward.

When I was sure that there was no vehicle coming from Lane 3 (the innermost lane) on my right-side, I drove my car slowly forward. Just as I did so, a red car (SLD 207H) cut across the double white lines from Lane 2 and caused a collision against my car (SMC 900H).

The impact resulted in damage to the right-front-side of my vehicle (SMC 900H) and also damage to both the left doors of his own vehicle (SLD 207H).
