As I look at the rear-view mirror, I saw a trail of water and I realize that the diesel from below the car had depleted drastically. I then decided to park my car and I saw white smoke came out at the front part of the engine and my car battery was flat. I went towards the trail of water to check and it was

As I was about to find help, I saw a white colored Toyota SKU6228E driven by Mr Lau Jia Jun drove fast and made a sharp right turn which ended up skidded and hit a Honda vezel SLN1349Y which was stationary park at the basement carpark lot.

The signage of 15Km/h was visually displayed at the carpark lot the speed that Mr Lau was driving was above the speed limit, I know that the carpark speed limit was 15km/h and i believe he was driving above the speed limit which resulted in him skidding his vehicle seeing him drive which could not evade this accident on time.

Behind the Toyota there was a grab food motorcyclist FBF 8152L Mr Khai ended up skidded when trying to drive in the carpark. He did not sustain any physical injury and was perfectly fine, he was able to pick up his motorcycle and continue to ride without any difficulties

On 28/02/2022 I contacted jaguar requesting for an appointment regard to having an issue due to an unusual noise that came in the car as well as to enquire on servicing , they told me the earliest appointment was allocated on 14/03/2022.

I would like to place in record there was no accident on my part and I was totally unaware of the leakage till I reach the basement carpark. When I approach the security officer of the condominium they were unaware and unclear of the safety protocol and managing of the situation.
