**Brief Details.**

# LIMA LIMO TRANSPORT SERVICES DRIVER'S AGREEMENT

THIS AGREEMENT is made this \_\_\_\_\_ BETWEEN  
M/S LIMA LIMO TRANSPORT SERVICES (RB NO. 53204251D) hereinafter referred to as "the Owner")  
AND

HASBI BIN ABDUL GHANI (NRIC NO. 51583974J) of Apt  
Blok 61 Geylang Bahari #12-3303 S(330061) (hereinafter referred to as "the Driver")

## WHEREAS:

The Owner is the owner of a TOYOTA WISH registered in 2008 and bearing registration number SKW 5845L (hereinafter referred to as "the Vehicle").


## IT IS AGREED as follows:

- 1) The Driver shall pay a daily maintenance fee of SS 43/-
- 2) The Driver shall drive the Vehicle for a period of 2 YEARS starting from 23-09-2021
- 3) The Driver shall pay a security deposit of SS 300/- to the Owner upon signing this agreement.
- 4) The Driver shall promptly pay for all summonses, fines and charges as a result of any forms of violation or infringement of traffic rules or the Road Traffic Act or any governmental regulations incurred from the usage of the Vehicle whether committed by the Driver or anyone authorized by him/her to drive or use the Vehicle.
- 5) The Driver shall fully compensate and indemnify and continue to indemnify the Owner of all claims, summonses, fines and charges made against him/her by any 3rd party arising from the default under clause 3 and the Owner shall claim from the Driver on a full indemnity basis if legal proceedings is commenced against him as a result.
- 6) The Driver shall fully pay the insurance's excess money incurred from any accidents from the usage of the Vehicle whether committed by the Driver or anyone authorized by him/her to drive or use the Vehicle.
- 7) The Driver shall not use the Vehicle for any purpose not permitted by the terms and conditions of the insurance policy and shall not do or permit to be done any act or thing which might render the insurance invalid.
- 8) The Driver shall inform the Owner of any charges needed for the servicing and maintenance of the Vehicle subject to approval from the Owner before proceeding with the servicing and maintenance of the Vehicle. Cost of tyre replacement will be borne by the Owner only when the tyres are replaced due to wear and tear. Other causes for tyre replacement such as punctured tyre, will be borne by the Driver.
- 9) The Driver shall be paid for downtime when the Vehicle is sent for inspection, servicing and 2 hours after Vehicle breakdown when the Vehicle is within Singapore only. All charges (repair and towing) for breakdown outside of Singapore, will be borne by the Driver.
- 10) The Driver shall return the Vehicle and its contents (one key) to the Owner at the end of the lease period stated in clause 1.
- 11) In the event the Driver:
  - a) Defaults on the daily rent for more than one (1) day; and / or
  - b) Defaults on clause 5; and / or
  - c) Defaults on clause 7;

This Agreement shall IMMEDIATELY be terminated and automatically cease to have any binding effect and the Owner shall have the right to take back the Vehicle with immediate effect and reserve their rights to offset from the security deposit all costs, expenses, damages and repair costs incurred. Should the security deposit be insufficient to offset all costs, expenses, damages and repair costs incurred, the Owner reserves the right to claim against the Driver such sums above the security deposit. Should the Driver fails or refuses to cooperate, the Owner shall have the right to undertake any legal actions it deems necessary.
