SKETCH PLAN

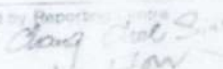

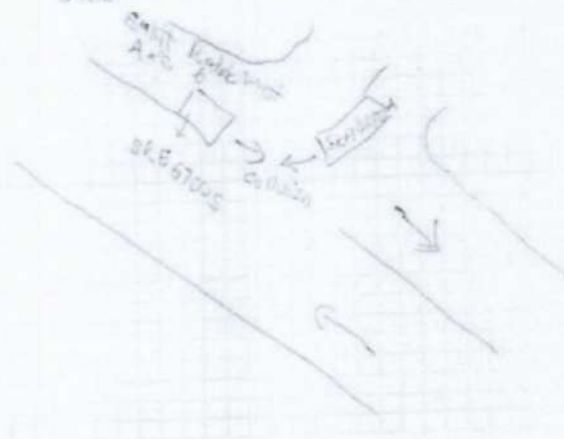
