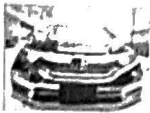

SKETCH PLAN

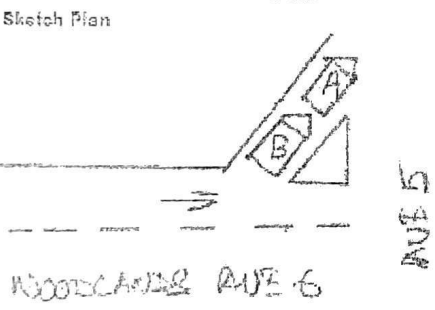


