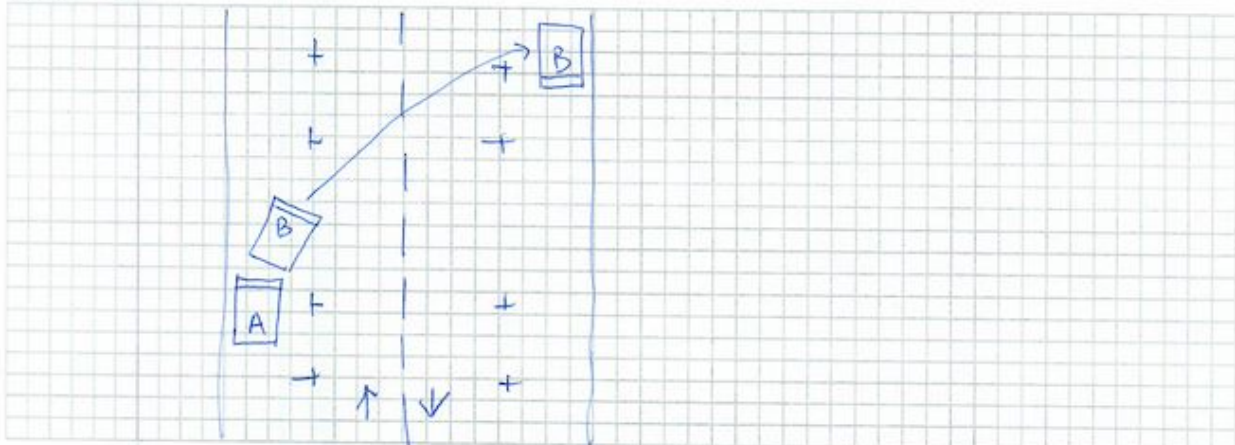

It was a white cerato (SJR8994R). After examination, I did not find any damage done to that car, thus I did not leave any note of notice.


