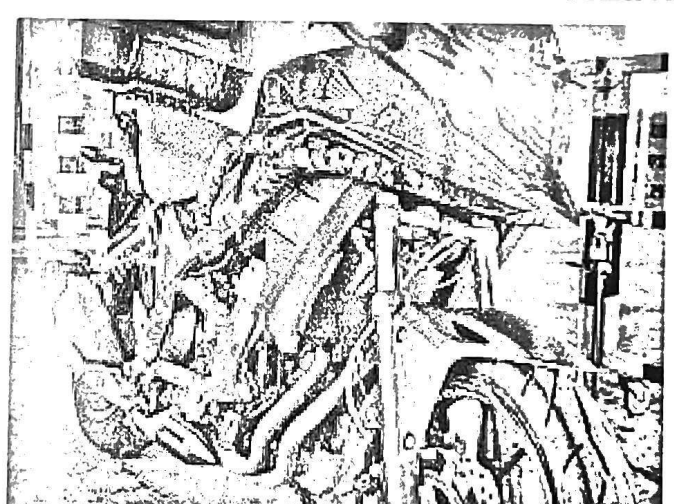

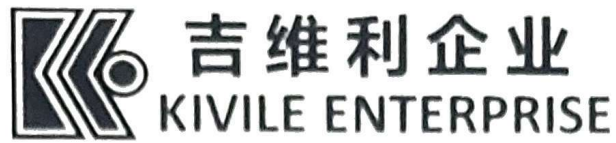

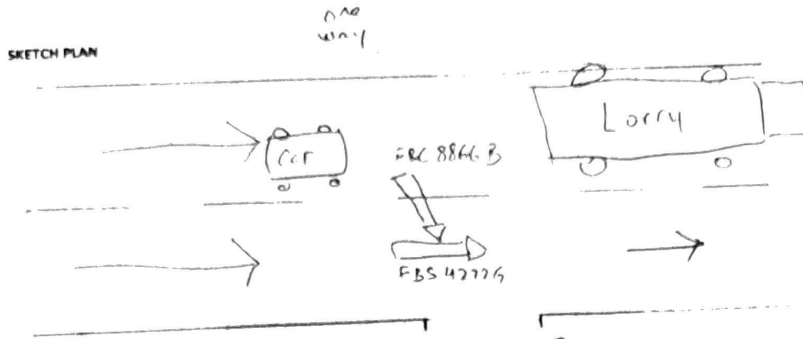

**Brief Details.**

On 09/03/2022 at about 1158hrs, I was riding my motorcycle bearing registration no: FBS4272G, along Irrawaddy Road. While approaching No. 53 Irrawaddy Road, I was riding on the right lane of the 2 lane road, when another motorcycle bearing registration no: FBC8866B, who was on the left lane, turned right and collided into my motorcycle. Due to the accident, I felt some aching on my left shoulder and swelling on my left knee. My motorcycle also sustained damages on the left side mirror and left handguard. There is also some rattling noise coming from my motorcycle but I am unsure from which part it is coming from. I then went to TTSH to seek medical treatment and the doctor informed me that there is blood in my urine and I was given 6 days MC. The accident was also captured on my motorcycle camera.
