We refer to the above matter.

Third party reported that he was travelling straight along Choa Chu Kang Way. Suddenly he felt an impact. Our driver who was driving on the right lane had changed lane and collided onto the right rear portion of third party vehicle.

Our driver reported that he signaled his intention to do a lane change. He checked and ensure that the traffic was clear before he proceed to change lane. While he was moving, third party travelled fast and cut into the lane which our driver was changing and collided with our insured's lorry.

Both parties had given a conflict of report and there was no video/ substantial evidence from both parties to support either version. In view is this, we would like to propose to settle the matter at 50/50.
