

Driving conditions: The weather was sunny/partly cloudy, the road was dry, and traffic was very light.

Details to the accident:

We were driving along Dover Road towards Clementi Road in the left lane.

We approached the traffic light at New Town Secondary school, which had just turned green which would have allowed right of way to comfortably continue through the intersection and onwards to Clementi Road.

Just before the light, as we were just about to pass Folkstone Road (a minor road coming from Medway Park onto the main Dover Road to our left) taxi (4184B, driven by Chien Yoa San, Simon, IC # S2595075E) did not wait at the stop sign at the end of Folkstone Road and darted left onto Dover Road and into our lane.

I swerved towards the right lane and started to apply brakes. There was nowhere and no time to avoid the oncoming car as the taxi not only entered our lane but was at an angle that continued to dash the left lane with the turn swerving beyond the left lane - entering the right lane leaving nowhere to go and no time to react.

The tax crashed into the passenger side of our car at a near 90 degree angle, the front grill of the taxi hit our car from our left front wheel to the edge of the rear passenger door.

The two cars came to an immediate stop within a meter of each other. We had to immediately move the cars as the rear of my car was partially blocking oncoming traffic (the right-hand lane driving towards Singapore Polytechnic) as well as both cars (our car and the taxi) entirely blocking the two lanes of Dover Road heading to Clementi Road. I parked our car along the left curb just before the crosswalk/light from NUS to New Town Primary School. The taxi driver backed his car back onto Folkstone road.

I exited the car and asked the driver if he was OK, and he stated he was fine. After I settled that my son was OK (he was upset and sobbing) I took pictures of both the cars. I approached the driver to exchange IC details, but he was
