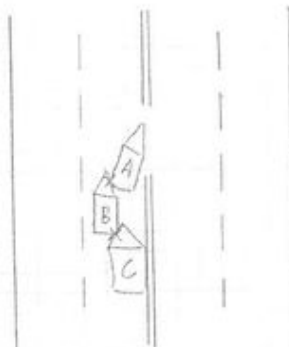

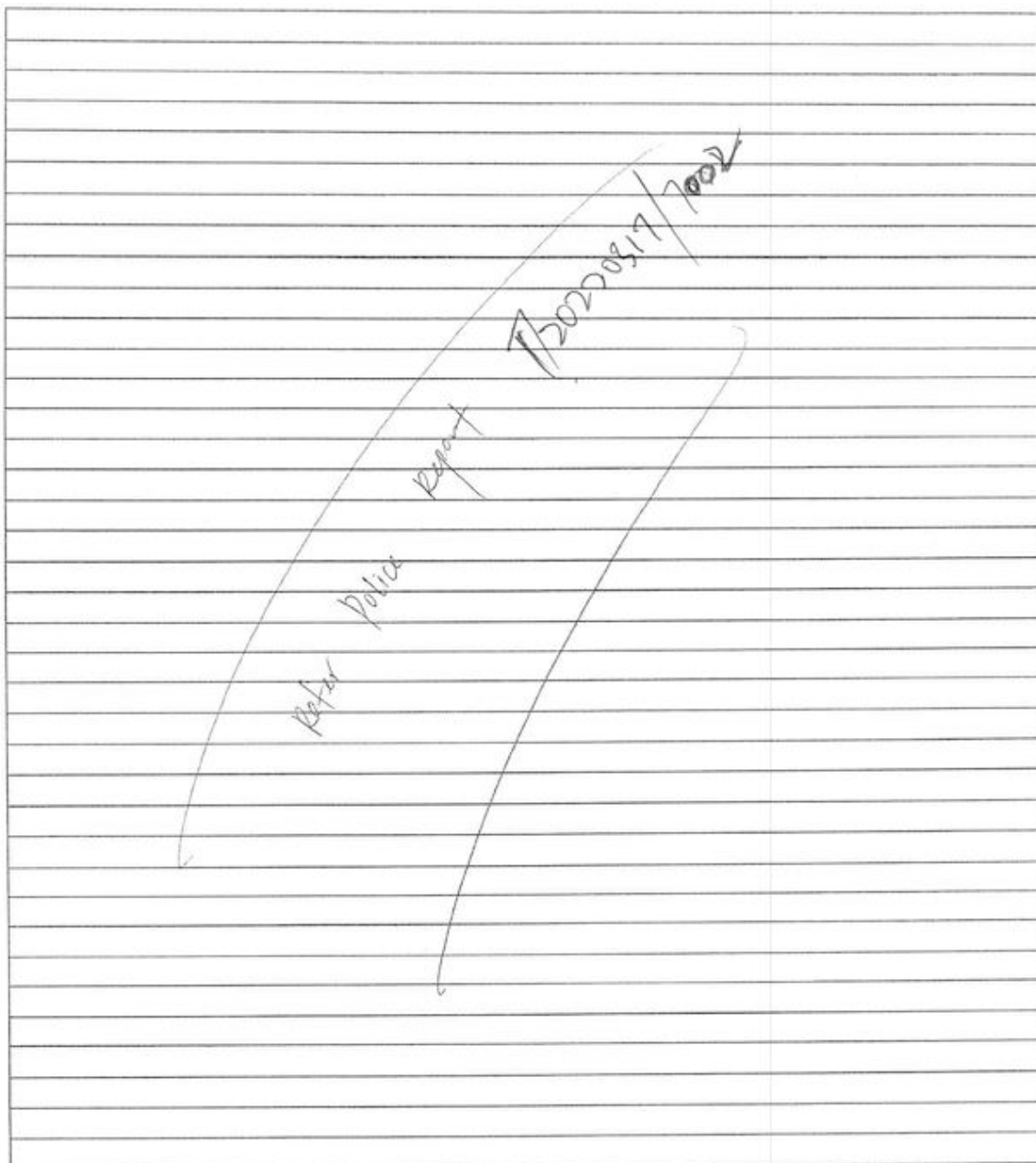

BRICK SQUARE AVENUE 1



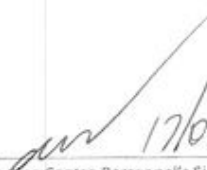

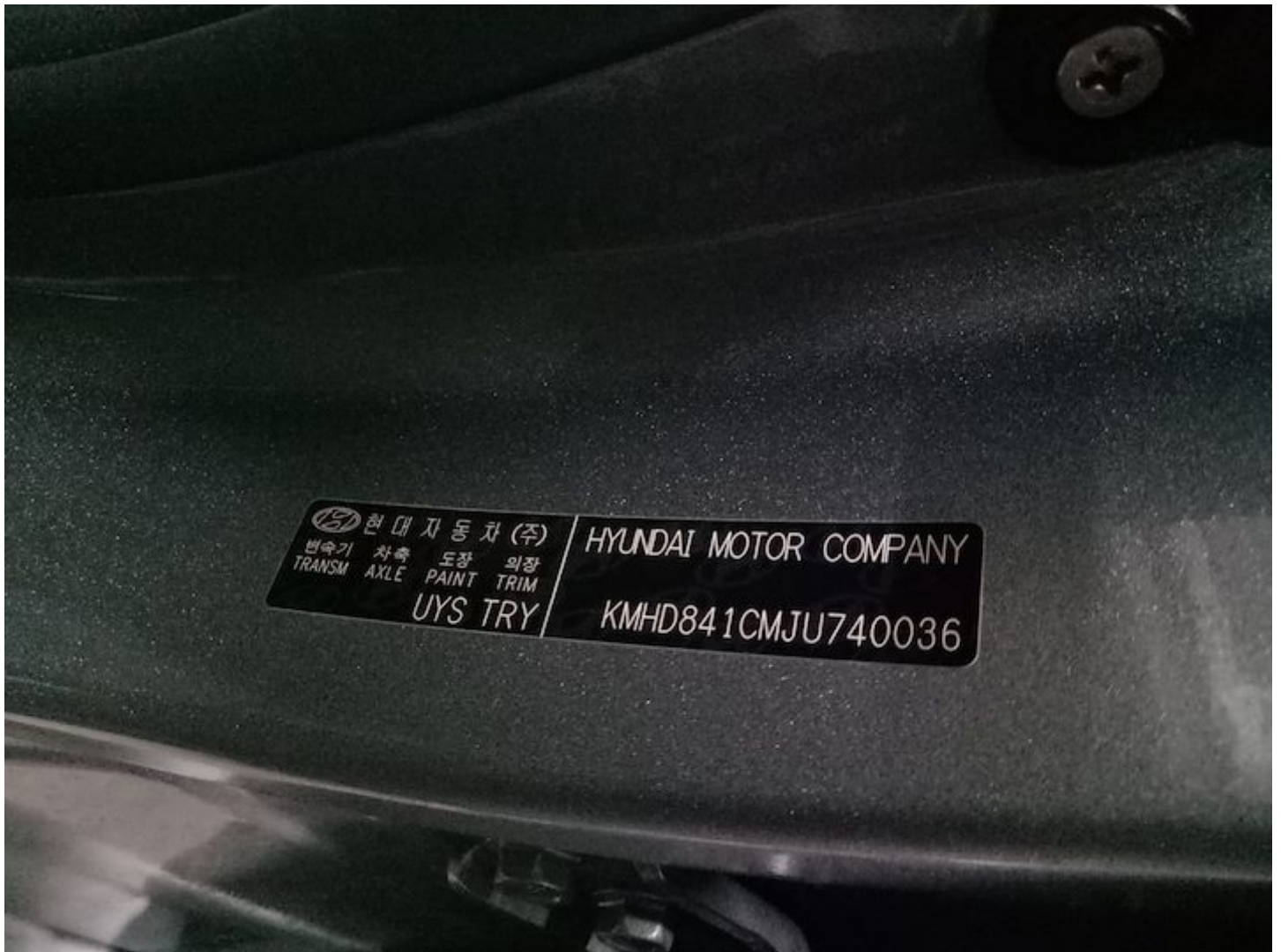
