We act for SAT WEE SIONG, the owner of vehicle no. SLL6688X, whose vehicle was damaged as a result of the abovementioned accident by vehicle no. SLJ7951P and our search reveals that you were the insurer of motor vehicle no. SLJ7951P at the time of the accident.
