I WAS ON MY WAY HOME FOR DINNER. I WAS DRIVING ALONG PIE (CHANGI) GOING TOWARDS TPE (SLE). I WAS ON THE SLIP ROAD MERGING INTO TPE (SLE), DRIVING BEHIND THE RED RENAULT SCENIC. THERE IS A TRAFFIC LIGHT AT THE SLIP ROAD AND IT IS GREEN LIGHTS IN MY FAVOUR JUST BEFORE THE ACCIDENT. BOTH THE CARS ARE STATIONARY BECAUSE THERE WAS SOME BUILT-UP TRAFFIC. I MOVED MY CAR SLOWLY FORWARD AND BRAKING SEVERAL TIMES BEHIND THE RED CAR. BEFORE I MADE THE LEFT TURN TOWARDS THE MERGING ROAD, I CHECKED MY BLIND SPOT ON MY RIGHT. I ASSUMED THE RED CAR IN FRONT OF ME HAD DRIVEN OFF AND I JUST PRESSED ON THE ACCELERATOR. THEN I KNOCKED ONTO THE THE BUMPER OF THE RED COLOUR WITHOUT REALISING IT.

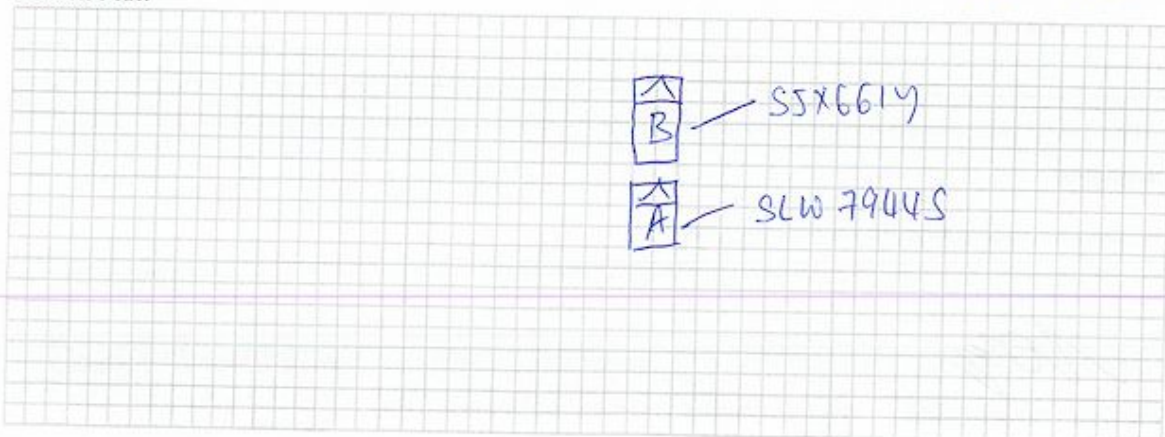

Describe Circumstances of the Accident

I was on my way home for dinner. I was driving along PIE (Uthangil) going towards TPE (SLE). I was on the slip road merging into TPE (SLE), driving behind the red Renault Scenic.

There is a traffic light at the slip road and it is green lights in my favour just before the accident. Both the cars are stationary because there was some built up traffic.

I moved my car slowly forward and braking several times behind the red car.

Before I made the left turn towards the merging road, I checked my blind spot on my right.

I assumed the red car in front of me had driven off and I just pressed on the accelerator. Then I knocked onto the bumper of the red colour without realising it.
