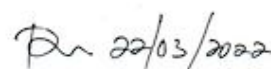

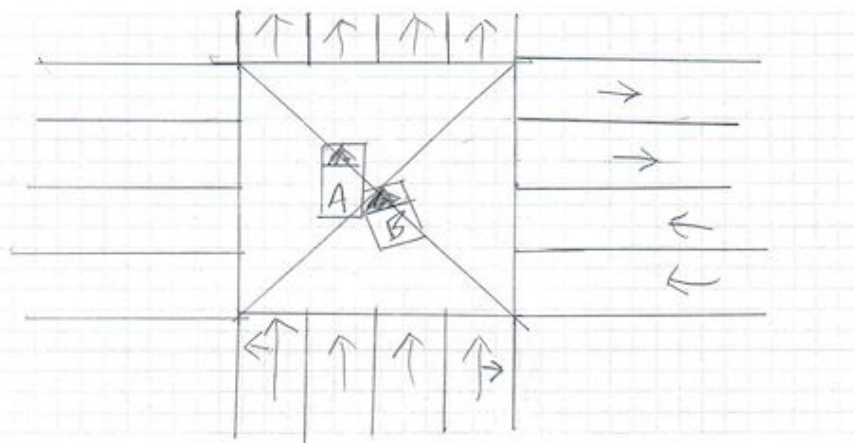

Describe Circumstances of the Accident

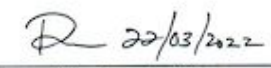
I was driving along at the stated venue and suddenly i felt an impact from the right side of my vehicle. It was vehicle B that had collided onto my right side portion of my vehicle.
