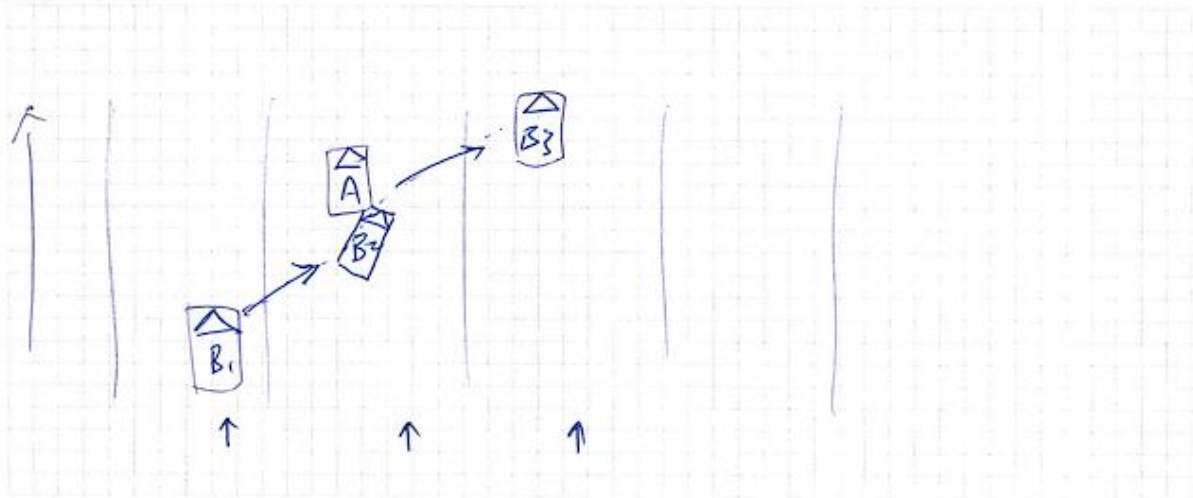

DESCRIBE CIRCUMSTANCES OF THE ACCIDENT

At about 7.16am, I was driving along PIE (Tuas) on the third lane at a safe distance from the vehicles around me. I was about to exit at the Euros exit when at the last moment, I glanced up the rearview mirror and saw a car accelerating towards me with speed, changing lanes abruptly from the fourth to second. That was when the car hit me whilst I was in the third lane. The car did not have its headlights turned on hence, I saw it only just before contact. We stopped at the road shoulder and assessed the damage and exchanged contacts. The driver was driving a rental car from Shariot carsharing. Shortly after, I was approached by a man who goes by Alex Lian, claiming to be a claims consultant. He passed me his name card and asked me to proceed to his workshop to get all repairs done. He also advised me not to make a police report. After that, he told the other driver who appeared very sleepy to go and rest. We all then parted ways after it was agreed that the other driver would fully compensate for all damages.
