

RENTAL FEE

: \$340 PER WEEK

Rental fee includes the following items:

- A. Unlimited mileage;
- B. Service and maintenance;
- C. Road tax and radio license
- D. Motor insurance coverage (excess applicable);
- E. 24-hours breakdown and emergency service (in Singapore only)

Without prejudice to the owner's other rights, the hirers will be liable to an administrative fee of \$\$50.00 plus 3% late interest payment (computed on a monthly basis) if the rental fee remain unpaid after becoming due. In the event, the rental fee remains unpaid for more than THREE (03) calendar days, the owner may lodge a police report as a lost vehicle and activate the vehicle repossession team to retrieve the vehicle. The incidental cost for the repossession process will be charged to the hirers.

a) All payments due hereunder shall be made to the owner at its address stated herein or such other address as the owner may from time to time communicate to the Hirers. Payment mode can be in cash, or via bank transfer to the following bank account:

- Additional named drivers can be included to drive the Vehicle with prior approval from the owner.
 - An administrative fee of S\$300 will be incurred for any request to change of the hirers particulars or vehicle.

EMERGENCY SERVICE, CAR BREAKDOWN AND MAINTENANCE.

- a) The Hirers shall at its own costs arrange to deliver the vehicle at the Owner's appointed date/time to the appointed workshop when the vehicle requires service and maintenance. Delivery service can be arranged at a nominal fee.
- b) Fail to turn up for the scheduled service and maintenance work may result to damages of the vehicle. The owner reserves its right to demand for the appropriate compensation from the Hirer for any repair cost resulted from the failure to turn up for the service and maintenance work.
- c) The Hirer must ensure that the vehicle has reasonable fuel, engine oil ,auto-transmission oil, radiator water at all times. Failure to perform may result to damages of the vehicle and the owner reserves its right to demand the damages from the hirer.
- d) The owner shall provide 24-hours breakdown and emergency service at no extra cost to the hirers if the Vehicle suffers a breakdown or is involve in an accident.

The 24-hours breakdown and emergency service arising from the use of the Vehicle outside Singapore will be borne by the hirers. The hirers agree that key locked inside the vehicle, steering wheel locked, changing of a punctured tyres and stalling caused by empty petrol tank do not constitute a breakdown. The Hirers accepts a charge of s\$80,00 if the 24-hour breakdown and emergency service is being deployed for such instances

6) DEPOSIT

- A) The Hirer shall upon signing this agreement pay to the owner a deposit (the Deposit) of \$\$0 as security. The Deposit shall maintain at the same amount during the Rental Period.
- B) The Deposit will be fully refunded, interest-free only when the hirer has fully discharge its obligations stated in this agreement after 45 days of the expiry of the rental period.
- C) The Deposit cannot be contra off as part of the monthly rental fee.
- D) In the event, the hirer fails to turn up for collection of the assigned vehicle within three (03) days from the date of the contract, the Deposit will be forfeited and the owner reserves the rights to claim for any contractual losses or damages from the hirers accordingly.
- E) Without prejudice to the owner's other rights, the owner shall be entitled to forfeit and /or retain any part of the Deposit in the event the hirer breaches, fails or neglects to pay any sums or charges due to or owing to the owner.
- F) In the event, hirer's wish to cancel the contact within the rental period, the deposit shall be forfeited and the hirer's need to pay another additional two weeks rental due to owner losses.
- G) Hirer's need to give the owner a one month notice if they wish to cancel the contact within the rental period.

HIRER'S COVENANTS

- a) The Hirer and Named Drivers must be between the age of 23 and 60 years old and possess a valid Singapore license with at least 2 years driving experience.
- b) The Hirers agree to indemnify the owner against all claims arising from the use of the Vehicle
- c) Use or permit the Vehicle to be used or operated in a manner contrary to the Singapore Law.

7) INSURANCE

- a) The owner shall insure the Vehicle against
- All 3rd party risks and liabilities
- Loss or theft to the Vehicle; and damage to the Vehicle. Subject to the appended Nonwaiverable Excess
- b) In the event of an accident, the Hirers shall:
 - Obtain vehicle registration numbers and addresses of the parties involved and of witness
 - ii) Not admit fault or liability;
 - Not abandoning the Vehicle without adequate provision for safeguarding and securing the same;
 - Notify the owner immediately and make police report if any party suffers injury.
 - v) The Hirer will be fully liable for all damages for any unreported accident.
 - Additional of S\$4000 insurance excess per accident for any drivers under 23 years old or less than two years driving experiences.

c) Non-Waiverable Excess:

- The Hirers will be responsible for the full amount of the excess, subject to GST, upon per report of the accident;
- The excess amount \$2500 should be paid to the owner, without demand, within 48 hours from the accident date/time. Failure to comply may lead to a termination of this contract, forfeit of the refundable deposit and / or any amount withhold by the owner. The excess amount \$1500 does not cover own damage of the car for section 2 of the insurance. The owner will reserve its rights to pursue any appropriate actions to recover the excess amount if the refundable deposit and/or the monies withheld by the owner is insufficient to cover the excess.
- Excess will only be refunded to the Hirers upon confirmation from the insurer on the percentage of liability on the Hirers.
- iv) Accident repair costs will be bear by the hirer
- Windscreen excess of S\$100, subject to GST, will apply.

8) TERMINATION

- a) Upon the termination of this agreement, not limiting to reference to sub-clause (B) below. The Hirers agree to pay to pay the owner:
 - All arrears of the rental and all other sums accrued and unpaid at the date of termination;
 - Cost of all repairs required at the date of termination;
 - III) Penalty computed as total Rental Fee for the remaining unexpired Rental Period.
- b) The owner reserves the right to terminate this Agreement if the Hirers:
 - Fail to pay the Rental fee or other payment remain unpaid for more than 14 days after becoming due;
 - ii) Commit a breach to any part of this Agreement;
 - iii) Do or allow to be done any act or thing in the opinion of the owner may jeopardize the owner's rights in the Vehicle.

9) USE OF VEHICLE

- a) The Hirer may use the Vehicle for business, social, domestic and pleasure purpose. The Vehicle is not to be used, and the Hirer agrees not to permit it to be used, for any purpose for which it is not expressly designed and not to use it for driving tuition, sub-leasing, towing, racing, pacemaking, or for competing in any form of motor sport or for any illegal purpose whatsoever.
- b) The Hirer shall be responsible for the petrol, Electronic Road Pricing and parking charges and Traffic fines arising from the use of the Vehicle provided by the owner during the course of the rental period.
- c) The Hirer accepts that the use of the Vehicle in Malaysia is subject to the Legislations of the Malaysian Government Singapore.

No forbearance indulgence or relaxation on the owner shown or granted to the Hirers in respect of any of the provisions of this Agreement shall in any way affect diminish restrict or prejudice the rights or powers of the Owner under this Agreement or operation as or be deemed to be waiver or any breach by the Hirer of the terms and conditions of this agreement.

13) GOVERNING LAW

This Agreement shall be governed by and construed in accordance with the laws of the Republic of Singapore and all parties irrevocably submit to the exclusive jurisdiction of the Republic of Singapore.
