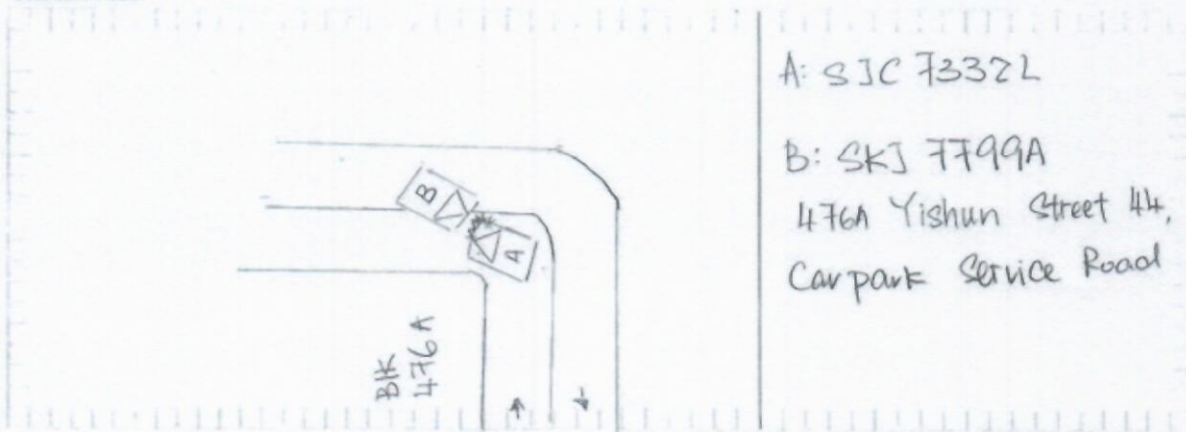

Sketch Plan



I was driving along 476A Yishun Street 44, carpark service road.


I saw the vehicle B come from the opposite direction encroach into my path, while I stopped my vehicle.


Veh "B" collided head onto the front portion of my vehicle and caused damages.


