Brief details.

On 08th March 2022 at approximately 0910hrs, I was hit by a car (white Toyota, make: unknown)- SKE 6306Y) while riding my motorcycle (FBH 4322D) at Kaki Bukit Avenue 3.

opposite direction without checking whether there is any oncoming vehicle, and hit me on my right side caused me to fell 'face down' in front of the car.

Two other riders (one of them is the witness, Mr.Marbin) helped me, they brought me to the curb area and helped to shift the bike to the side of the road.

The car driver (Mr. Li Fu, ic: S2711763E, HP: 91763677) came out and apologized multiple times and said, 'sorry, I didn't see"

I sustained injuries on my legs (below knee on both legs, right ankle, abrasions on both legs), my right elbow, abrasions / scratches on both of my palms and felt pain on my lower back.
