### Without Prejudice

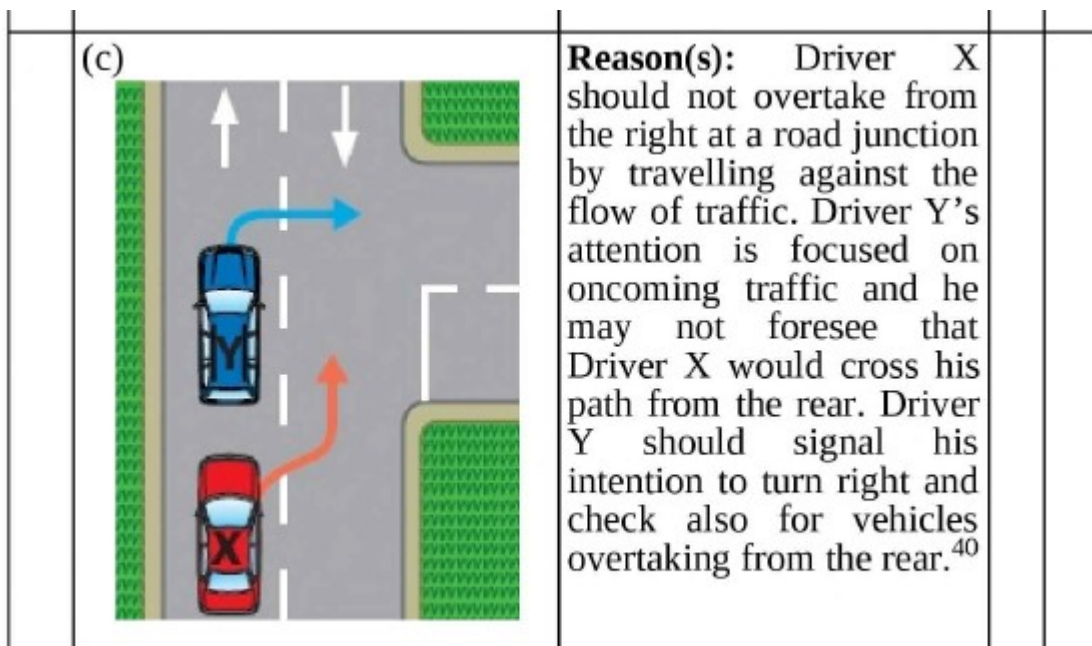
Dear Sirs/Mdm,

I refer to our phone-conversation this morning in regard to the above mentioned vehicle accident claim.

I understand that your company LKK Auto Consultants Pte Ltd is the new appointed claim adjuster that taking over from PJ Knights Pte Ltd for Singapore Ministry of Defence.

As spoken, the processing of the above mentioned claim has been going on for a very long time and is yet to conclude due to the previous claim adjuster of PJ Knights had been insisting on a traffic police investigation report for their conclusion.

However, despite our numerous attempt in contacting the traffic police via phone calls and email since the beginning of the accident, we regret that todate we are yet to receive such investigation report from the traffic police.
