On 11/05/2021 at about 12.10pm, our company vehicle GBK5997J was travelling along Old Choa Chu Kang Road behind a military vehicle 95206MID. Upon reaching the slip road before Chinese Cemetery Path 10, your insured military vehicle stopped and switched on the hazard light. As such, our driver checked for on-coming traffic from the opposite direction as he intended to overtake the military vehicle. He then decided to overtake the military vehicle on its right side.

While in the process of overtaking the military vehicle, the military vehicle suddenly turned right into Chinese Cemetery Path 10. This resulted in a collision between our vehicle and the military vehicle. Our vehicle sustained dents to the left passenger door and above the left headlight area.
