CIRCUMSTANCES OF ACCIDENT

On 11/3/2022 at around 0656hrs, I was travelling on the middle lane of 03 lanes along Bukit Batok West Avenue 8 heading towards the direction of Choa Chu Kang Bus Interchange on Svc 991, SG5586G. My bus speed was around 40-45km/hrs. After bus was exiting out from bus stop, I continued to move on and travelling straight along the middle lane heading towards the next bus stop for my pax activity. While bus was passing the exit road of Dulwich college, I noticed that there was a pte car travelling on my left side. As bus was almost passing the side road, I heard a thud sound from the left rear portion of my bus. Upon hearing this, I immediately turned my head to check and saw that the bus left rear body was grazed by a third-party car making its lane change from left to right and grazed against my bus to result in this SS accident case. Upon seeing this, I immediately stopped my bus at scene to conduct damage checks. While conducting the damage checks, I realized that my bus-SG5586G had the Left rear body scratched while the third-party Car had its Front right body scratched.


