Brief Details.

On 25/03/2022 at about 2000hrs, i was driving my vehicle (SLV1741E, White Honda Grace) at lane 1 along TPE towards Ang Mo Kio. The vehicle that was in front of me (SJW4829K) suddenly brake. I also pressed on my brakes and i managed to stop in time. The car behind my vehicle (SMA1350Z) also managed to stop in time. However, the fourth car that was behind (SMA1350Z) did not managed to stop in time and collided with the third car, subsequently causing a chain collision. I wish to state an ambulance and also Traffic Police Officers attended to the scene. However, no one was conveyed at the scene.
