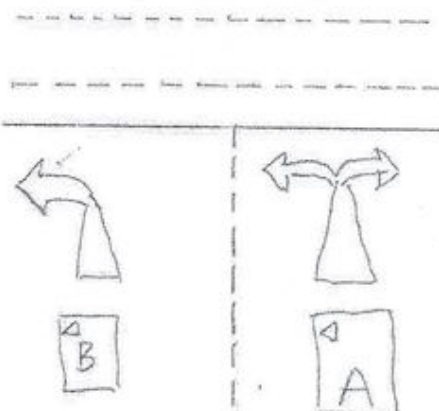
Sketch Plan
