RE: ORDINARY MEDICAL REPORT FOR MARK CHIN TZE LEONG

Mr Mark Chin Tze Leong is a 43-year-old gentleman who was involved in a road traffic accident on 13/12/2021. Patient was a driver and was knocked by a vehicle. Following the accident, he was seen in National University Hospital with regards to his neck pain and right-hand pain secondary to the injury. Following his initial evaluation, he was still having persistent pain and symptoms. In view of the worsening pain, he was initially seen by his general practitioner on 22/12/2021. He was subsequently referred to the specialist clinic and reviewed by me on 27/12/2021. At clinical review, he indicated of persistent neck pain and pain overlying the right hand. There were also symptoms of radicular pain overlying the right upper limb.

Clinical assessment revealed positive Spurling's sign on the right side with no major myotome or dermatome deficits in both upper limbs. Reflexes were assessed to be normal and Hoffmann's test was unremarkable. He also had pain overlying the right hand in the carpometacarpophalangeal joint (CMCJ) region. His clinical diagnosis was cervical strain with right hand contusion. In view of his persistent symptoms, I advised him on MRI to be done for these musculoskeletal injuries. MRI of the cervical spine ruled out cervical spinal cord abnormalities. There was disc protrusions and osteophytes seen in the cervical spine. With regards to the hand MRI, there was no acute osseous injuries. Based on these clinical findings and the clinical assessment, his diagnosis is acute cervical strain injury presenting together with right hand contusion.

Based on his clinical diagnosis and clinical findings, I advised him to consider physiotherapy as well as to be treated with medication consisting of Myonal, Neutron, and Reparil-Gel. Following the physiotherapy review, he underwent physiotherapy sessions on 31/12/2021 and 10/1/2022 with ultrasound therapy as well as cervical muscle strengthening exercises. He was substantially better at the review on 10/1/2022 by the physiotherapist and given an open date. I have also advised the patient should the symptoms be recurrent then to present for a clinical evaluation with a view to appropriate surgical intervention if clinically indicated. If costs of future treatment and relevant clinical literature are required, please write in for a specialist medical report.
