### Medical report for MARK CHIN TZE LEONG S7832699I

I am Adrian Lin Zhigao, employed as a locum doctor in the Emergency Department (EMD) of the National University of Singapore. I completed my MBBS in the University of Adelaide, South Australia, in 2013, and completed my Housemanship in Singapore in 2014. I had been through postings in General Medicine, Orthopaedic Surgery, and General Surgery before starting my medical officer posting in EMD in May 2020, and subsequently converted to a locum doctor on 21 Sep 2020. I am a fully registered medical doctor in Singapore, my MCR is M60355D. I am also a registered Designated Workplace Doctor with GDOM certification.

I have been asked by ALP L'aw Corporation Advocates & Solicitors to provide an ordinary medical report. It must be understood that this medical report is based on the electronic medical note made by myself on the day of consult.

Mr Chin is a 43 year old man who presented to us on 13 Dec 2021 following an alleged road traffic accident on the same day. According to the patient, he was hit on the left by a car that was changing lane. His airbags were not deployed, and his car was drivable after the accident.

Mr Chin complained of right shoulder and neck pain after the accident. There was no reported head injury or any symptoms suggestive of a nerve injury.

Physical examination revealed some tenderness over the shoulder and shoulderblade. There was some pain on moving the shoulder. There was no identifiable nerve injury. Plain radiograph of the shoulder, shoulder blade, and neck did not reveal any fracture or dislocation. Mr Chin was discharged from the EMD with painkillers, medical leave, and an appointment on 22 Dec 2021 for review with an Orthopaedic surgeon for a possible right shoulder rotator cuff injury.
