
## SKETCH PLAN



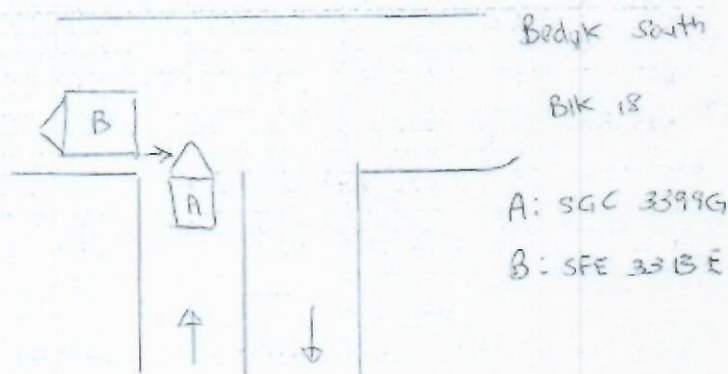

his insurance.


