ON THE STATED DATE AND TIME. I, VEHICLE A (GBG6915K) WAS TRAVELLING ON LANE 1 OF LOYANG WAY TOWARDS LOYANG AVENUE. I WAS IN THE LANE THAT CAN GO STRAIGHT AND TURN LEFT WHILE I MAKING LEFT TURN.
