Brief Details.

On 16/03/2022 at about 2230hrs, I was cycling along Pasir Ris Drive 12 towards Pasir Ris Industrial Drive 1 on the left most lane. While passing by the slip road exiting from TPE, I noticed a car at the slip road. However I continued to cycle thinking that the car should have seen me. However the car did not stop and collided on my left side of my body. I then fell and hit onto my head. I felt dizziness but I was still conscious at that time.

The driver then stopped his car and rendered help to me and drove me back to my house. No Police or ambulance was called up at that time. After reaching home, I still feel dizzy, as such I went to Sengkang General Hospital for a check up. I was admitted on 17/03/2022 and discharged on the same day. Doctor diagnosed me with "Subdural Haemorrhage, posterior falx" and given me 9 days of Medical Leave. I do not remember the vehicle plate number of the car that collided onto me however I had exchanged particular with the driver. It is a yellow car taxi. There is a in-car camera on the taxi that collided with me.
